
Dear Director Tony Keck,

My name is Whitney Kinsey-Lykes. I am writing this letter to you on behalf of my daughter, Haylee, who is 5 years old and has Sickle Hemoglobin D disease with Alpha Thalassemia trait. This is a rare form of Sickle Cell Disease and her condition has not changed since birth. She has been receiving Tax Equity Fairness and Responsibility Act (TEFRA) Medicaid Disability until recently when I received a letter this week from them stating that her coverage will be stopped as of June 1, 2013 because she no longer qualifies for this benefit.

I do not understand this decision as her condition has not changed and will not improve over her lifetime. I have tried to get life insurance policies on her, but have been denied because of her condition. She has the unfortunate chance of having a stroke or heart attack at any time. Every year, Haylee has a Doppler study of her brain performed to make sure that the circulation in her brain is not compromised by her condition. With her condition being rare, the doctors in my area are not sure how to treat her and go by treatment that is routine for a child with sickle cell disease. She has had several hospitalizations through her life and treated with IV Rocephin to reduce fevers and IV fluids to keep her hydrated. She is on daily medication to keep her hemoglobin from dropping and an antibiotic that is a routine treatment for children with sickle cell. When her fever rises, she is hospitalized to make sure that she is not in crisis or that it does not worsen.






Thank you for contacting our Agency regarding the closure of your daughter, Haylee Lykes', Medicaid case.
