I have been contacted by my above-referenced constituent, Chris Hall, who is having difficulty being approved for Medicaid.

Mr. Hall is a 46 year old male who suffers with several medical conditions, one of which is being a severe diabetic. On January 14, 2010, Mr. Hall woke up totally blind. After having several operations on his eyes, he has only regained partial vision in his right eye. His left eye is still totally blind.


Mr. Hall does not have any health insurance. He has to take about \$1350.00 worth of medicine each month. He has been able to get some assistance to get him to this point, but now that assistance is running out. The only way he was able to have the initial surgery on his eyes was because he had a doctor that had compassion for his situation and did the surgery without him having insurance.

Mr. Hall applied for Medicaid in March 2010, but was denied.

My office and Mr. Hall have spoken with Nancy Bracey at the Medicaid Office in Bennettsville and she has assisted us as much as possible. I would appreciate your looking into this matter for Mr. Hall and doing anything you can to assist him with being approved for Medicaid. 
Medicaid uses the same disability rules as the Social Security Administration (SSA) to determine eligibility for the Aged, Blind or Disabled (ABD) program. Your most recent ABD application was denied on July 20, 2010 because we are required to adopt SSA's disability decision. In the future, should your disability status change, please contact our Marlboro County Medicaid Office at (843) 479-4389.

An alternate health insurance option through AugeoBenefits offers a variety of health insurance plans from top-rated insurance carriers. You may wish to look over the enclosed brochure and contact them at 1-866-273-5613 or visit their website at www.augeobenefits.com/sc to see if they can assist.

Enclosed is information on other programs and organizations that can assist residents in South Carolina with their healthcare services, prescriptions, inpatient hospitalization and daily living needs.
