Here is the logistics info:

- Date/Time: Wednesday, November 12 from 1:30pm to 4:00pm
  - Note: Our goal will be to complete the meeting by 3:30pm. But, I've reserved the room until 4:00pm, in case we need it.
- Location: The IMPH offices are located in the Tower at Gervais, which is the 20-story brown building at 1301 Gervais Street (one block from the SC State House between Sumter and Marion Streets). This is the same building where IT-oLogy and Bank of America are located. We will meet in the conference room on the first floor of our building.
- Parking: You can park in the Keenan Garage that can be entered from Marion Street at the side of the building.
