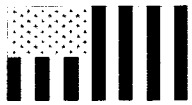

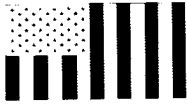
AND TAKE FURTHER NOTICE THAT the material facts giving rise to the constitutional question are as follows:
