Ms. Hill:

Pursuant to the provisions of the South Carolina Freedom of Information Act (FOIA), this is a formal request to you and/or the custodian of your records for access to the following financial records of the Charleston Area Convention & Visitors Bureau.

- 1) Your general ledger, including line-item details of all revenues and expenses for the last two (2) fiscal years.
- 2) A list of all current employees, by job title, and their salaries.
- 3) Time sheets for all employees as they relate to and support your Form 990 IRS filings and the issue of unrelated business income tax (UBIT).
- 4) The total amount of your public (accommodations tax) funding for the current fiscal year, as well as any other sources of state or local public monies allocated to the organization by any government entity.

Per the requirements of the SC FOIA, you are required to respond within 15 days.

And because a significant portion of your operating funds come from public sources, I expect the request will be met.

Since this request primarily benefits the general public, I hereby request that any search or copying fees be waived. If there is a charge for providing access to the records, please advise me of your estimate of such charges and the basis for the charges when you contact me to arrange an appointment for inspection of the requested records.
