Post and Courier: Gov. Nikki Haley: South Carolina recovering swiftly after historic floods

South Carolina is returning to normal quickly from the historic, damaging flooding, Gov. Nikki Haley said on Wednesday. Road closures are down 48 percent, from 541 to 281, Haley said during a press conference from the S.C. Emergency Management Division's headquarters. Of the roads that are closed, 84 have bridges.

Note: Leatherman, who heads the Senate's state budget writing panel, said legislators will likely revisit a borrowing plan that died last year after Haley likened the effort to running up the state's credit card.

Note: Haley, however, said it was too soon to start discussing borrowing. "Right now, I'm just trying to get us through a storm," she said. "In all honesty, we have not had time to think about the legislative session coming up. There will be a time and place for that."

Gov. Nikki Haley began a Wednesday afternoon press conference saying the state is on a roll in terms of recovery. The governor praised the state's Department of Transportation workers' progress in getting roads open in a matter of eight days.

Note: "I am so proud of DOT," she said. "I am very proud to say we are down 48 percent thanks to the crews and maintenance work from DOT."

Note: "South Carolina is on the move, we are excited because we are knocking out all of the challenges that get in our way," she said. "Team South Carolina has said from the beginning 'can't' is not an option, so we're going to continue to move in that direction."

Note: "The reason we want you to call and register through the United Way is because in order for us to help those people in need, we get assistance based on the number of volunteer hours," she said. She acknowledged her team made a mistake last week when they volunteered at the Harvest Hope Food Bank, because nearly 30 people worked for about an hour each and that volunteer time was not counted because they had not registered.

WCIV: Haley: No need for special session of Legislature to deal with flooding aftermath

South Carolina Gov. Nikki Haley says she will work with members of the General Assembly to help the state recover from the recent floods, but she still sees no need for lawmakers to return for a special session. Haley was asked at a news conference Wednesday about House Speaker Jay Lucas' call for hearings in the Ways and Means Committee to deal with potential costs of the flooding.

Note: Haley again called for more widespread help from people across the state, but this time it came with the announcement of "Team South Carolina" days that would focus attention on victims in specific areas, delivering to them all the help and resources they need to rebuild.

Note: "If you have a need, you register with the United Way. If you want to help, you register with the United Way. And they match you up," she said.

Gov. Nikki Haley signed an order Thursday extending the state of emergency in South Carolina for 15 days

so the National Guard can continue helping with cleanup efforts. Haley said the South Carolina National Guard is currently helping rebuild 74 roads across the state. She said guard members have also helped repair the Columbia Canal and Columbia's drinking water system and rescued people from flooded homes. **Note:** "We are on a roll. We don't want things to slow down," Haley told The Associated Press on Thursday. "This is a good thing."

Note: "That was in anticipation of what we didn't know was going to happen," Haley said. "Now we want them to finish the work they are doing. It's really a good thing." The governor said she doesn't anticipate having to sign another state of emergency when this one expires in 15 days.

Area Development: Magna International Plans \$50.8 Million Manufacturing Plant In Greenville County, South Carolina

Maryland is likely to begin recalling Maryland license plates with images of the Confederate flag this fall after a federal judge agreed on Thursday to lift a 1997 injunction that prevented the state from taking the specialty plates out of circulation. U.S. District Judge Marvin J. Garbis issued an order that allows Attorney General Brian Frosh (D) to lift the injunction.

Note: South Carolina Gov. Nikki Haley (R) signed a bill in July to remove the Confederate flag from the statehouse grounds. A week after the bill signing, the flag was taken down.
