
**Dear Director Forkner:**

At the request of your grandmother, Patsy Bell, Representative Roland Smith asked our agency to assist with your questions and concerns regarding Medicaid eligibility.

We are pleased to inform you that Evahnee Sweeney has been approved for Medicaid coverage effective February 1, 2008. Therefore, she will continue to receive Medicaid without any break in coverage.

You currently receive Medicaid coverage under the Family Planning program. However, our Aiken County office is reviewing your case to determine eligibility under the Low Income Families (LIF) program. We cannot make an eligibility determination until we receive the *Medical Support Referral Form 2700 (enclosed)*. We mailed you a letter requesting this important information and once we receive it we will make a decision and notify you. Please call Ms. Ann Jackson at (803) 642-7512 if you have questions regarding the requested documentation.

We have enclosed information on programs that may help with daily living expenses. You may also wish to contact the Aiken County Department of Social Services at (803) 642-3603 for information about daycare services and the Financial Aid Office of Aiken Technical College at (800) 246-6198 for help with educational expenses. If you have other questions regarding Medicaid, please contact Ms. Sheila Chavis at (803) 898-2707 or 1-(888) 549-0820 Ext. 2707.
