Per our discussion, attached please find the two letters that I referenced in our discussion—Governor Perry and Governor Scott. In addition to these two letters, we have publicly received support from Governor Riley, Governor Beebe, Governor Otter, Governor Brandstad, Governor Bryant, Governor Perdue, Governor Dalrymple, Governor Sandoval, Governor Fallin, and Governor Tomblin.

We have also received public support from 52 Mayors, 52 Airports (including Charleston and Columbia Airports), and 50 Chambers of Commerce from across the country. We would very much like to add Governor Haley to this growing list of supporters who want to see American Airlines emerge from bankruptcy quickly so that (1) we can continue to provide service to communities around the country and the world; (2) continue to employ over 53,000 domestic employees around the country; and (3) continue to generate economic activity for the states and cities that we so proudly serve. As we discussed, AA's estimated economic impact to the state of South Carolina was over \$285 million in 2010. In that same year, we carried over 344,000 passengers into and out of the state of South Carolina.

To reiterate, we are not asking you or the Governor to pick and choose winners or losers; we are, however, asking that the Governor to support a company that has faithfully provide service to her state for decades.
