Attached is PRF #3 for services and backup documentation. Please note the following:

1. We have not received payment for PRF #2 that was the Bingo for HDM for the month of July (units were put in on August 3).
2. I received corrected PRF #1 (with no explanation) deleting the amounts in Column (b). I put them in on this one as a negative amount. This was cash on hand at 6/30/14. If it is excluded from the PRF column we will continue to have cash on hand. We have emailed twice asking for a telephone conversation to see what the issue is with this and gotten no response at all.
3. On page 20 of the MUSR IIIb-d with NSIP I have marked a place where Mary Beth cannot put a budget in AIM, however Our contractor can put in the correct units. AIM help has been emailed the question and we have received No response. I calculated the amount that should show in IIIB by adding the 27.60 (.60\*46 units) so that our monthly total will be correct when the issue is resolved in AIM.
4. Several adjustments were made to federal and state amounts in order to match the budgets on the grant award. The adjustments were +/- \$1.
