1. We are planning on printing some foam board visuals to have on display on either side of the podium. Do you have two easels that we could use to display them? The boards will probably measure 3.5' x 5' or a close approximation of that dimension.
2. To confirm, will your office will take care of drafting and sending media advisory, and sending out the press release we provide?
3. For the press release: we have the digital artwork for the foam boards—one of them is a really nice infographic of the life of the loan. Would you be adverse to embedding it in or attaching it to the release?
