Chief Keel:

I am respectfully requesting that your agency open an internal investigation into the official misconduct and corruption of the Horry County Police Department involving the case number above. The above named and unnamed officers with the Horry County Police Department as well as the Plaintiff, Jeff Whiteis, whom is a former Horry County Police Officer and also a self proclaimed "Computer Guru" had me maliciously and falsely arrested without probable cause or an arrest warrant for 2nd degree harassment on April 9th, 2016. The acts of Jeff Whiteis and this case fall under the Key Factor of "False Victimization" as illustrated on <https://en.wikipedia.org/wiki/Cyberstalking> and referring to my original complaint request mailed to you on 3/27/16. (see attached)

Since my arrest, they have delayed my case to allow them time to cover up their actions. The questionable representation by my former attorney leads me to believe that he violated my Attorney-Client Privilege as well as the SC Rules of Professional Conduct in favor of the State. On October 18th, 2016, I disengaged with this attorney. The Plaintiff, State, and the Officers involved have duplicated the unofficial arrest warrant, falsified related police reports, did not notify me of court hearings, failed to provide me with a complete Brady-5 discovery on two separate requests which would exculpate me of this charge, and have gained unauthorized access to my website accounts through 3rd parties to try and validate the Plaintiff's story and this illegal arrest. It is unknown at this time whether the Honorable Bradley Mayers was aware of any misconduct involving the duplicate arrest warrant which he had signed. (see attached)

In addition, the State and/or my former Attorney have repeatedly sabotaged me from obtaining legal representation as evidence of (8) separate attorney's refusing to accept this misdemeanor case since terminating my former attorney's representation. The State is denying me the right to representation to take advantage of me by having to represent myself *Pro se*, which favors the State in a jury trial. I have (2) separate uploaded iCloud accounts of this case file which consists of overwhelming supporting evidence including audio, video, and witness testimony that clearly dismisses the charge and the validity of their case. Due to the continuous official misconduct and the cover-up attempt, this entire case file is and continues to be updated and shared with State and County officials including Government Agencies.

Per my original complaint request mailed to you and pursuant to Attorney Jonny McCoy's case law, please provide me with the Due Process of the Law just as you did for him in 2009.

My name is Brian Crumling. I can be reached at (843) 855-4330 and I currently reside in Myrtle Beach with my daughter. Since approximately 2007 primarily myself but also my 12 year old daughter (whom I have sole custody and am a single father) and my immediate family members whom reside in NJ, FL, and SC have been the victim of repeated Interstate Cyber-Stalking, Stalking, Intimidation, and Harassment to some extent by the same presumed group of anonymous individuals. I do not have the resources to hire a P.I. or an attorney because they have repeatedly sabotaged my employers, self-employment businesses, and other forms of income in every aspect and at every level. I am determined to end this criminal pyramid and I will not stop until an acceptable resolution is finalized. I, my daughter, and my family will no longer be subject to these criminal acts anymore! With all the requests and complaints for help filed over the years in all states without any investigative resolution, there is no reason why this matter should not be investigated with a combined effort by all agencies down to the core of the problem and prosecuted to the fullest. Please help me with this matter before it continues, as it has, to get even worse ultimately resulting in some sort of a tragedy.

specifically for that attack for reasons of anger, revenge or control. Cyberstalking can take many forms, including:

1. harassment, embarrassment and humiliation of the victim
2. emptying bank accounts or other economic control such as ruining the victim's credit score
3. harassing family, friends and employers to isolate the victim
4. scare tactics to instill fear and more<sup>[6]</sup>

## Identifying and detecting cyberstalking

CyberAngels has written about how to identify cyberstalking:<sup>[8]</sup>

When identifying cyberstalking "in the field," and particularly when considering whether to report it to any kind of legal authority, the following features or combination of features can be considered to characterize a true stalking situation: malice, premeditation, repetition, distress, obsession, vendetta, no legitimate purpose, personally directed, disregarded warnings to stop, harassment and threats.

A number of key factors have been identified in cyberstalking:

- **False accusations.** Many cyberstalkers try to damage the reputation of their victim and turn other people against them. They post false information about them on websites. They may set up their own websites, blogs or user pages for this purpose. They post allegations about the victim to newsgroups, chat rooms, or other sites that allow public contributions such as Wikipedia or Amazon.com.<sup>[9]</sup>
- **Attempts to gather information about the victim.** Cyberstalkers may approach their victim's friends, family and work colleagues to obtain personal information. They may advertise for information on the Internet, or hire a private detective.<sup>[10]</sup>
- **Monitoring their target's online activities** and attempting to trace their IP address in an effort to gather more information about their victims.<sup>[11]</sup>
- **Encouraging others to harass the victim.** Many cyberstalkers try to involve third parties in the harassment. They may claim the victim has harmed the stalker or his/her family in some way, or may post the victim's name and telephone number in order to encourage others to join the pursuit.
- **False victimization.** The cyberstalker will claim that the victim is harassing him/her. Bocij writes that this phenomenon has been noted in a number of well-known cases.<sup>[12]</sup>
- **Attacks on data and equipment.** They may try to damage the victim's computer by sending viruses.
- **Ordering goods and services.** They order items or subscribe to magazines in the victim's name. These often involve subscriptions to pornography or ordering sex toys then having them delivered to the victim's workplace.
- **Arranging to meet.** Young people face a particularly high risk of having cyberstalkers try to set up meetings between them.<sup>[12]</sup>
- **The posting of defamatory or derogatory statements.** Using web pages and message boards to incite some response or reaction from their victim.<sup>[13]</sup>

## Prevalence and impact

According to *Law Enforcement Technology*, cyberstalking has increased exponentially with the growth of
