**SUGGESTED TALKING POINTS:**

- It's a tremendous honor to be here with you today.
- It's always special to see a group of people coming together to make a difference, and by raising awareness of the challenges disabled South Carolinians face, you really are making a difference.
- As elected officials and the people who are charged with leading our state, it's our responsibility to make sure your voices are heard.
- My administration is committed to meeting the needs of all South Carolinians, but especially those South Carolinians who are disabled and need a helping hand to live their lives to the fullest.
- That's why my administration continues to support the Exceptional Needs Tax Credit in the budget, which enables special needs students the flexibility and choice they need in education.
  - The Tax Credit provides up to \$10,000 per student for tuition, transportation and text book expenses for exceptional needs students attending independent schools.
  - I also signed a bill earlier this year to provide an extended timeframe for qualifying schools to apply for this program, thus granting greater access and more options to exceptional needs students.
- From somebody with autism to someone with a physical handicap due to trauma, our citizens with disabilities are fully capable of living a meaningful and full life, but some may need an extra bit of support to make sure that happens.
- That's why my Executive Budget proposed \$6.6 million in recurring support to continue directing resources to reduce waiting lists at the Department of Disabilities and Special Needs, and another \$1.2 million in recurring support to transition individuals from institutional to community care settings.
- But like every other issue South Carolina faces, our people are the reason I know we will see brighter days.
- South Carolinians continue to amaze me with their grace and their love for one another, and the real heroes that are here with us today are those of you who dedicate your lives to serving our citizens with disabilities.

- Thank you for your service to our state and our people, and thank you for letting me be here with you today.

**WHEREAS,** thousands of South Carolina residents and families are impacted by severe lifelong disabilities including autism, traumatic brain injuries, spinal cord injuries, and intellectual and related disabilities; and

**WHEREAS,** people with lifelong disabilities are productive citizens, neighbors, and family members, deserving of respect and opportunities for economic self-sufficiency, independence, and personal growth; and

**WHEREAS,** South Carolinians with and without disabilities work together, play together, worship together, learn together, and grow together; and

**WHEREAS,** family members, caregivers, and service providers selflessly offer daily care, assistance, supervision, and physical and emotional support to individuals with disabilities to help ensure their full participation in community life; and

**WHEREAS,** the 2016 observance of Disabilities Awareness Month celebrates 27 years of successes of people with disabilities in education, employment, and community activities.

**NOW, THEREFORE, I,** Nikki R. Haley, Governor of the great State of South Carolina, do hereby proclaim March 2016 as
