### S.C. Sues US Department of Energy:

South Carolina filed a lawsuit on Tuesday intended to keep the federal government from defunding a multi-billion dollar project to turn weapons-grade plutonium into commercial nuclear reactor fuel, saying its closure would hurt an international nonproliferation agreement and eliminate hundreds of jobs.

**Note:** "They made a promise," Gov. Nikki Haley said at a news conference at the Statehouse, of President Barack Obama's administration. "They cannot, for whatever reason this is, decide that they are going to go on cold standby."

**Note:** "They have messed with the wrong state," Haley said, of the administration's decision not to finish the MOX project. "We are going to protect the people of the Savannah River Site. ... Enough is enough."

The State of South Carolina is filing suit against the Department of Energy over its decision to freeze the funding for construction of the MOX facility at the Savannah River Site. Gov. Nikki Haley said the decision to put MOX in a cold stand-by is President Barack Obama's mission to follow his own rules rather than honor the MOX contract.

**Note:** "It's a facility that DC started, and with plutonium sitting there...and now you're going to stop MOX?" Haley questioned during a press conference in the Statehouse. "They're hurting the people of South Carolina, and we're not going to sit back and take it."
