The regular monthly meeting of the Highways and Public Transportation Commission was held at the offices of the State Highways and Public Transportation Department in Columbia, South Carolina, at eleven o'clock a.m. on June 19, 1991. In compliance with the "Freedom of Information Act", the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Minutes for the meeting of May 16, 1991; copies of which have been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion accepting monthly reports as published by the Department of activities for the month of May, 1991.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00 during month of May, 1991, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion concurring in the action of the Department in entering into an agreement with Sverdrup Corporation to begin Phase III of the Conway Bypass project in Horry County at an estimated cost of \$7,000,000, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in entering into supplemental agreement #1 with Stevens and Wilkinson, Inc. for additional engineering services to the I-385/Route 49 interchange in Laurens County at an estimated cost of \$106,000.00, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement #2 with Campco Engineering, Inc. for additional engineering services on the Anderson Bypass/Connector Corridor in Anderson and Abbeville counties at an estimated cost of \$2,200,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into written agreements with the Urban Mass Transportation Administration (UMTA) to carry out the Department's statewide public transportation responsibility in accordance with the requirements of the UMTA Section 8, 16(b)(2), 18 and Rural Transit Assistance Program, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing award of a building contract to Fuller Enterprises, Inc. for the construction of a section shed in Beech Island at a low bid of \$172,921.00, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing award of a building contract to Fuller Enterprises, Inc. for the construction of a section shed in Hickory Grove at a low bid of \$168,812.00, as shown in the Appendix.

SECTION 10: On motion of Commissioner Chapman, seconded by Commissioner Atkinson, the Commission unanimously passed a motion to modify the proposed budget for maintenance which eliminates driveway installations entirely to become effective January 1, 1992 in order to give delegations and public notice of this policy change.

SECTION 11: On motion of Commissioner Self, Chairman of the Finance and Capital Improvements Committee, seconded by Commissioner Harvey, pursuant to the requirements of Code Section 57-11-40 and 57-11-50, the Commission unanimously passed a motion adopting the following estimates of revenues and requirements for fiscal year 1991/92:





This supplement is estimated to cost \$2,200,000.00 and will be funded under the SHIMS program.

Agreement With The Urban Mass Transportation Administration

The Department has filed application with the Urban Mass Transportation Administration (UMTA) of the U. S. Department of Transportation to receive and administer the UMTA Fiscal Year 1991 Grant Apportionments.
