South Carolina Governor Nikki Haley on Wednesday called on the Oklahoma Supreme Court to order immediately a 3-year-old Native American girl returned to a South Carolina couple who adopted her, escalating a bitter custody dispute with the girl's biological father. The Oklahoma Supreme Court ruled last week that the girl known as "Baby Veronica," who will turn 4 next week, will not immediately be transferred from her Oklahoma biological father, Dusten Brown, despite other court rulings ordering him to give her up to adoptive parents Matt and Melanie Capobianco of Charleston, South Carolina.

Note: "This matter should come to an end, now," Haley said in a document prepared for the Oklahoma high court and given to Reuters by the governor's office.

Note: "Under the laws of South Carolina and Oklahoma, the minor child should be immediately returned to the Capobiancos' physical custody and care," Haley said.

BMW Expands and Relocates Operations to Greer:

The State: BMW Expanding, Relocating Its Export Operations To Greer

BMW is expanding its export program to emerging markets, moving its operations closer to the new inland port being built in Greer. The company announced Wednesday morning that it also would expand the program to include the new BMW X5. The program originally was announced in 2011 to support export of the BMW X3 Sports Activity Vehicle, the company said in a release. The company will move its export operations to a new 413,000-square-foot building adjacent to the South Carolina Inland Port, which will ship products from the region to the Port of Charleston by rail when it is completed. That is nearly triple the size of the current plant and has the potential to be expanded to 750,000 square feet. The company expects to make its first shipment from the new location in January.

BMW Manufacturing Co. said today it is building a new export center next to the State Ports Authority's inland cargo facility near the luxury automaker's Greer factory. The move stems from the German company's decision in 2011 to ship more of its X3 sport utility vehicles to emerging markets, including Russia, Thailand, India, Indonesia, Malaysia and Egypt. That strategy is being expanded to include the new X5. As part of that, BMW is moving its Upstate export hub from a 156,000 square foot building in Duncan to the SPA's so-called inland port site.

BMW announced Wednesday plans to locate a new facility near the Inland Port under construction near Greer – more than doubling the size of the automaker's exporting operation in the Upstate. The automaker says it plans to move its export operation from its facility in Duncan to a new building near the Inland Port. Once completed, the facility will occupy 413,000 square feet – up from 156,000 square feet at the current location – and it can be expanded to 750,000 square feet. The new facility is expected to make its first shipment in January 2014, according to a written statement from the company.

Greenville News: Tech Enterprise Campus OK'd; school hopes to break ground next year

Greenville Tech hopes to break ground next year on a special facility for training manufacturing workers now that Greenville County Council has given final approval to borrowing \$25 million for the project. Members of County Council voted unanimously Tuesday night in favor of borrowing \$25 million to build the Enterprise Campus with one member absent and another abstaining because he's applied for a teaching job at the school. If the bonds are also approved at the state level, Greenville Tech should be able to break ground in the fall of 2014, said Keith Miller, president of the college. County Council was originally facing a small property tax hike in order to pay for the Enterprise Campus, and it wasn't clear there were enough votes for the bond issue.

The event will take place at the South Carolina Troopers Association, 4961 Broad River Road, at 7:00 p.m. Columbia Tea Party Chairman Jack Hatfield will moderate, according to a release from Bright's campaign. Graham has three Republican primary challengers, including Bright, currently in his second term in the S.C. Senate. Also challenging Graham are Nancy Mace, owner of a Charleston marketing firm, and Richard Cash, an Anderson County businessman who owns a fleet of ice cream trucks and a used car dealership.

Associated Press: Judge dismisses suit over SC party registration

A federal judge has dismissed the Greenville County Republican Party's lawsuit seeking to limit primaries to registered supporters. U.S. District Judge Mary Lewis said in an order released last week that the county party did not have the legal standing to sue to close the state's primaries. Any voter registered in South Carolina is allowed to participate in one primary election per cycle without declaring a political affiliation. In 2010, the Greenville County party's executive committee filed a federal lawsuit saying South Carolina's open primary system denied the party its First Amendment rights to free association. The suit was aimed at forcing the Legislature to require voters to register by party before primary voting. The state GOP was initially part of the lawsuit but dropped out earlier this year.

The State: Columbia City Council Votes To Open Round-the-clock Homeless Shelter

Columbia City Council voted unanimously Tuesday to open a 24-hour, seven-day-a-week emergency homeless shelter for seven months beginning Sept. 24. Council approved general guidelines for how it will proceed in dealing with the city's homeless people. But council did not enter a formal contract with Christ Central Ministries, the organization that is slated to run the shelter. That contract will be discussed at council's Sept. 17 meeting. The city will provide the same amount of funding it did last year, \$500,000 in a contract with Christ Central Ministries. It also will pay for about \$40,000 for costs associated with utilities.

The State: SLED looks into missing money in Lexington County magistrate court

The State Law Enforcement Division is looking into a report of missing money in an unidentified magistrate court in Lexington County. SLED spokesman Thom Berry confirmed the investigation Wednesday, saying only that it is under way. He declined further comment. County Council hasn't been briefed on the situation, council chairman Bill Banning of West Columbia said. The amount of money allegedly missing isn't known. There are nine magistrates in the county. The judges handle traffic violations as well as misdemeanor offenses that have a maximum penalty of 30 days in jail and \$500 fine. They also handle small claims matters up to \$7,500 and landlord-tenant disputes.

Obamacare makes many significant changes to the U.S. health-care system, but one category of change stands out above all others: the degree to which the law reshapes the market for individually-purchased health insurance. Will the "Affordable Care Act" live up to its name and make health insurance less expensive? To help the public understand the impact of Obamacare on individual-market premiums, my Manhattan Institute colleagues and I have crunched the numbers and created an interactive, state-by-state map, where you can find out how Obamacare affects insurance rates where you live. The results may surprise you. In less than four weeks—on October 1, 2013—Obamacare's subsidized insurance exchanges are supposed to be fully on-line. But as of today, the relevant governmental agencies have only made public the insurance carrier filings for 13 states and the District of Columbia. In other words, we're still waiting for important information on health insurance premiums from nearly three-fourths of the states.

The world is in a bind. Syria has violated basic norms of international law and humanity by using chemical

weapons on its own people. The United Nations, which is supposed to secure international peace, is paralyzed by the intransigence of Russia and China, which hold vetoes on the Security Council.
