SECTION 1: The Minutes for the meeting of January 27, 1995, copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion authorizing the release of all "C" Funds for Edgefield County, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion amending Section 16 of the November 18, 1994 Minutes to read as follows:

On advice of the FHWA and in keeping with Section 1105(h) of the ISTEA which requires that the funds be used only for feasibility and design studies, the federal grant for I-73 of \$400,000.00 is to be used for a corridor analysis which includes the various alternatives, including the route preferred by this Commission.

SECTION 4: The Commission unanimously passed a motion amending the Resolution of Route I-73 adopted at the November 18, 1994 meeting, as shown in detail in the Appendix.

EDGEFIELD COUNTY TRANSPORTATION COMMITTEE
REQUEST TO ADMINISTER "C" FUNDS

The Edgefield County transportation Committee has formally requested that the South Carolina Department of Transportation release all "C" Funds designated for their use. These funds are to be released to Edgefield County for administration by the County Transportation Committee. Future funds are to be transferred on a quarterly basis. It is recommended that the Commission grant this request.

Commission Minutes - November 18, 1994

The Department requests that the Commission amend Section 16 of the November 18, 1994 Minutes to read as follows:

On advice of the FHWA and in keeping with Section 1105(h) of the ISTEA which requires that the funds be used only for feasibility and design studies, the federal grant for I-73 of \$400,000 is to be used for a broad based corridor analysis which includes the various alternatives, including the route preferred by this Commission.

RESOLUTION - ROUTE I-73

The Department requests that the Commission amend the resolution regarding Route I-73, which was adopted at the November 18, 1994 meeting of the Commission to read as follows:

RESOLUTION

Whereas, the United States Congress in its passage of the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA) designated Route I-73 as a high priority route, and

Whereas, the location and designation of this route in keeping with the National Environmental Policy Act, is left to the discretion of the various states in which the route is to be located, and

Whereas, it appears that the United States Congress will not authorize additional interstate mileage thereby prohibiting the construction of this road to interstate standards and making it preferable to locate the route along an existing highway that can be upgraded as part of the national highway system currently awaiting approval by Congress, and

Whereas, the public and political acceptance of the Corridor location is divided among the various regions being Florence, the Grand Strand, and the area between the two, and

Whereas, economic benefit will be recognized regardless of which location is selected, existing and planned economic development must be served, and

Whereas, the metropolitan area connectivity from a point somewhere between the Grand Strand area and Florence appears to be more satisfactory, and

Whereas, the Commission has recognized the need for improved traffic flow in the Florence area by expediting the four-laning of U. S. Route 52 to better facilitate traffic demands in that corridor, and

Whereas, the Commission has also agreed to expedite the construction of the Conway Bypass which will facilitate traffic in and around the Grand Strand would appear to be more favorable, and

Whereas, from an environmental standpoint a location between Florence and the Grand Strand would appear to be more favorable, and

Whereas, utilizing the criteria to upgrade existing roads the estimated cost would favor a route that currently exists between the grand Strand area and the Florence area, and

Whereas, traffic utilizing such a facility would be higher in the grand Strand area as opposed to Florence or a mid-point area, and

Whereas, given all of the aforementioned factors, the South Carolina Department of Transportation Commission desires to designate this facility so as to serve the needs of the traveling public, contemplated industry, the economic well being of the State, and the citizens of South Carolina,

Be it Resolved, the Commission of the South Carolina Department of Transportation hereby determines that the preferred route for I-73 within the borders of South Carolina is the corridor outlined below:

Beginning at and including the new Cooper River Bridge at Charleston, utilize US Route 17 to Georgetown, from Georgetown US Route 701 to Conway and from Conway follow the current location of US Route 501 including the Marion Bypass, and from Marion utilize SC Route 38 crossing I-95 in the vicinity of Oak Grove Community, continuing along Route 38 around or through the Towns of Brownsville and Blenheim to the Town of Bennettsville utilizing Route 9 and US Route 1, exiting South Carolina along US Route 1 near the Town of Wallace.
