The regular monthly meeting of the Department of Transportation Commission was held at the offices of the State Department of Transportation in Columbia, South Carolina, at 8:30 a.m. on March 17, 1994. SECTION 1: The Commission unanimously passed a motion authorizing the Department to enter into a contract with Sandlapper Construction for Phase II (Canteen) at an estimated cost of \$47,400.00, as shown in the Appendix.

SECTION 2: The Commission unanimously passed a motion authorizing the allocation of funds for capital improvements/land and buildings, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion amending the June 17, 1993 allocation of Federal and State Public Transportation Project Funds, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional resurfacing work, as shown in the Appendix.

SECTION 5: On motion of Commissioner Jefferson, seconded by Commissioner Mullinax, the Commission unanimously passed a motion approving, on an interim basis, County Transportation Plans for Chester, Lee, Williamsburg, Charleston, Florence, Pickens, Union and York Counties, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing award of contracts covering resurfacing projects in the March 8, 1994 letting, as shown in the Appendix.

## WILLIAMSBURG COUNTY TRANSPORTATION COMMITTEE

### County-wide Transportation Plan:

Williamsburg County has approximately 2,240 miles of publicly maintained roads. The S. C. Department of Transportation has about 1,300 miles of this, including Interstates. Williamsburg County Department of Transportation maintains about 940 miles of roads, with all of these being paved roads.

The basic concept behind the establishment of the "C" Fund gasoline and fuel tax was to pave dirt roads, enabling farmers to carry their products to the appropriate market. This was the reason they have been called farm-to-market roads. In addition to the farming interests, the population of Williamsburg County has increased. In 1970, Williamsburg County had a population of 34,243; in 1990, 36,815.

The Williamsburg County Transportation Committee, working closely with the Legislative Delegation, has developed a "Priority Ranking System" which rates all publicly maintained petitioned dirt roads from a technical standpoint. This system is to be updated on an annual basis by the Williamsburg County Transportation Committee.

The Williamsburg County Transportation Committee proposes using this system in the majority of funds provided through "C" Fund Programs. On a case by case basis other "Special Projects" will be evaluated as to need and availability of funds. These projects will be used to make improvements on public roads. At this time, without a Local Paving Program, special projects will be limited to State maintained roads.

It is the opinion of the S. C. Department of Transportation that the new law prohibits the Local Paving Program. This needs to be addressed in the next legislative year. Williamsburg County has participated in this with a very high level of success. Some of these short petitioned roads can be paved with less "C" Fund money and also faster than going through the South Carolina Department of Transportation. The CTC does have the capability to do the work required on these roads, including engineering, right-of-way acquisition, contract administration, etc., through the County Department of Transportation.

Attached also is a sample of Williamsburg County Department of Transportation's Priority Ranking System. This System allows for a road paving schedule based on need with the primary weight on cost of maintenance. This cost is reported by each maintenance crew weekly and entered into the computer to be evaluated on an annual and per mile basis. Number of homes is determined whenever a traffic count is taken (approximately every three years) and

school bus routes are determined annually through the school districts.

The "Priority Ranking System" will be used on a county-wide basis, and all special project will be evaluated and recommendations made to the CTC for a vote. Due to the change in allocating "C" Fund money, a master list of projects will be submitted with cost estimates and priority of funding by the CTC.

By law, CTC can elect to receive the money directly, but there are several important unanswered questions at this time. Until these issues are resolved, programmed projects will proceed through the South Carolina Department of Transportation. If the Local Paving Program is written back into law, the CTC will utilize this as a method of making improvements on County roads.

The County Director of Engineering will be the primary contact with the S. C. Department of Transportation as to "day-to-day" questions.

The County Transportation Committee will review and vote on all prior commitments made by the Legislative Delegation not yet let to contract.

"C" FUND RANKING PROCESS

The following information and data is gathered for each petitioned road in Williamsburg County.

1. Petitioned road name
2. House district
3. Council district
4. Maintenance district
5. Location/map grid
6. Year petitioned
7. Petitioned length
8. Total length of road
9. Average annual maintenance cost (past 5 years)
10. Number of houses/mobile homes on petitioned portion
11. Average daily traffic
12. School bus route or not

Once the information has been gathered on each petitioned road it is run through a program which assigns a total weighted value to each road as follows:

Average annual maintenance cost divided by total length of road = average annual maintenance cost per mile.

From this information a maintenance cost factor is assigned to each petitioned road as follows:

For Maintenance Cost Per Mile:

Less than 1000 -----	Give Maintenance Cost Factor = 50
1000 to 2500-----	Give Maintenance Cost Factor = 100
2500 to 3500-----	Give Maintenance Cost Factor = 150
3500 to 4500 -----	Give Maintenance Cost Factor = 200
4500 to 5500-----	Give Maintenance Cost Factor = 250
5500 to 6500-----	Give Maintenance Cost Factor = 300
Greater than 6500-----	Give Maintenance Cost Factor = 350

The density per mile is determined and also the average daily traffic. If the road is a school bus route then the traffic count is increased by one-tenth.

The total weighted value = Maintenance cost factor + density/mile + average daily traffic.

The roads which receive the highest total weighted values are the roads which Williamsburg County recommends and these should be considered for paving.







## SECTION I. ADMINISTRATION OF FUNDS

The Charleston County Transportation Committee (CTC) will accept the responsibility to administer its funding in Charleston County as prescribed in the amendments to S.C. Code 12-27-400 by Appropriations Act (Section 23, Part II, Act 164 of 1993).

Through accepting this responsibility, the CTC elects to receive its allocation of funds on an annual basis to implement the Transportation Plan described herein once approved by the South Carolina Department of Transportation (SCDOT) Highway Commission.

The primary goal of the CTC will be to cooperate and coordinate with the local governments and SCDOT in maintaining existing secondary SCDOT roads and local government roads in Charleston County and to improve as many unpaved roads as practical.

At its initial public meeting held on December 15, 1993 the CTC delegated coordination of the CTC's County Transportation Plan to the County of Charleston with the daily responsibilities of the program being managed by its Department of Public Works located at 4350 Azalea Avenue, North Charleston, South Carolina 29405-7492. ~~The Department of Public Works will work with the CTC to coordinate, administer, and oversee the CTC's Transportation Plan. Its duties will be to provide administration services, design, engineering, quality control and materials testing, inspections and investigations, right-of-way acquisitions, procurement, financial accounting, contracts preparation, bidding, construction administration, legal services, as well as providing an annual report to the SCDOT detailing its compliance with minority and women-owned business requirements under S.C. Code 12-12-1320 in its programs.~~

## SECTION II. CTC TRANSPORTATION SYSTEM MANAGEMENT

The CTC anticipates its funding to be utilized on a countywide transportation network that will consist of the SCDOT's secondary road and bridge system and the County and municipal governments' road and bridge system. Since road system needs far exceed the available funds and obviously every need cannot be addressed, the CTC has purposefully chosen to exclude roadways for funding consideration that are considered Interstate, U.S., and SCDOT primary routes, unless specific requests or extenuating circumstances arise that require it.

The CTC will manage and administer its local government program by developing and adopting the required Standard Specifications for Local Governments' Road and Street Construction as required by legislation. Additionally, a uniform Countywide Pavement Management System (PMS) will be developed for the entire local and State road and bridge system under consideration.

The initial PMS will include a comprehensive inventory, technical analysis, and evaluation of the CTC's existing countywide transportation network of roads and bridges. It is anticipated that the initial PMS technical information will be gathered and analyzed by an independent consultant under contract to the CTC. It is recognized that in order to achieve a timely and uniformly controlled PMS for the approximate 1,325-mile paved transportation network that the CTC program will address, the initial technical evaluation and computerized data base for the system should be accomplished as a contract service.

The consultant will utilize, or develop, a detailed pavements rating system that accurately assesses the current status of all paved roads in the countywide network.

The PMS will provide the CTC (without regard to political boundaries or jurisdiction) proposed maintenance schedules, surface condition analysis, and recommendations on existing roads. It will allow for coordinated management of the road system in conjunction with local governments' routine maintenance and construction programs. Utilizing the adopted pavement rating system, the PMS will be updated yearly by County staff to provide the CTC with current road conditions on an annual basis. Information generated by the PMS, coupled with various intangible factors, will be used by the CTC to assist in selecting those maintenance projects warranting funding.

In order to simplify program management and provide the needed financial controls, the CTC will manage and administer its construction and maintenance program locally through the Charleston County Department of Public Works with the cooperation of other local governmental agencies including the SCDOT. By adopting a singular centralized management structure, the CTC anticipates taking advantage of several opportunities including better competitive bids on single, large multi-jurisdictional contracts, centralized accounting controls for simplified fiscal monitoring and required audit reports, comprehensive and uniformly controlled materials testing procedures to insure consistent quality control standards, and reports to the SCDOT assuring the CTC's annual projects include funding to comply with the minority and women-owned business requirements under South Carolina law for "C" Funds.

SCDOT Projects: Local "C" funded project management on the SCDOT highway system will be performed either by the Charleston County Department of Public Works through a written agreement between the County and the SCDOT, or, if appropriate, by the SCDOT itself. All work will be designed and constructed in accordance with the SCDOT's current edition of its Standard Specifications for Highway Construction, the AASHTO Standard Specifications for Highway Construction, the AASHTO Standard Specifications for Highway Bridges (including the latest interim specifications for each), AASHTO's Policy on Geometric Design of Highways and Streets and any modifications which may be recommended and approved by the SCDOT and/or the Federal Highway Administration. SCDOT-certified inspectors will be principal inspectors on all SCDOT projects to insure compliance with current SCDOT road specifications and testing procedures. Any and all project engineering, design, or testing on the SCDOT highway system must be performed by, managed by, or under control of the SCDOT through a contractual agreement approved by SCDOT officials.

Local Government Projects: Any project under local government jurisdiction will be designed and/or constructed to meet the Charleston CTC's Standard Specifications for Local Governments' Road and Street Construction in Charleston County. These projects will be supervised and managed locally through the Charleston County Department of Public Works, with assistance from local governments and after approval and programming by the CTC. ~~Funding for all local projects will be designated by the CTC and will not exceed limits established by State Legislation.~~ Project selection and fund distribution will be done in an equitable manner between unincorporated and incorporated areas of the County.

The CTC reserves the right to review and revise the County Transportation Plan from time to time, make changes, additions or deletions which will be forwarded to the SCDOT for approval.

### SECTION III. PROPOSED FUNDING ALLOCATIONS

#### Priority No. 1

Maintenance, Rehabilitation, and Reconstruction  
(Annual Expenditure: Up to 70 percent of annual funds)

Due to limited funding and continual deterioration of the existing local government and State secondary road and bridge system, the CTC will consider the repair and rehabilitation of this system as its primary and top priority. Projects considered for funding under this classification will include, but will not be limited to, resurfacing, seal-coating, rebuilding, and various improvements and upgrades on both earth and paved roads and bridges.

The CTC will utilize the Countywide Pavement Management System plus recommendations from the SCDOT and local governments to assist in selecting projects in this category for funding. The CTC's desired roadway maintenance cycles for resurfacing or overlays of asphalt is every fifteen to twenty years for each road. Routine maintenance, such as shoulder or median mowing, pothole repair or patching, ditch and pipe cleaning, street sign installation or replacement, etc. will be the responsibility of each jurisdictional government responsible for perpetual maintenance and not funded through the "C" Fund Program.

In developing the CTC's recommendations for maintenance projects with the countywide transportation system, the following information database will be utilized:

- Distance, surface type, and condition of each SCDOT-maintained secondary road
- Distance, surface type, and condition of each County-maintained road
- Distance, surface type, and condition of each Municipal-maintained road
- Location, type, and condition of each SCDOT-maintained bridge on secondary roads \*
- Location, type, and condition of each County-maintained bridge \*
- Location, type, and condition of each Municipal-maintained bridge \*

Priority No. 2  
New Construction Projects

Proposed projects considered by the CTC under this priority will be site-specific projects and fall under one or more categories. Each request will be considered by the CTC as a separate issue and can be placed under separate headings such as Road Construction and Improvements or another heading such as Safety Projects depending on type, number of requests, and available funding.

Road Construction and Improvements could consist of, but not be limited to, categories for building new roadways or paving and/or rocking existing earth roads for business or economic development, improving community access, recreation sites, etc.

Safety Projects could consist of, but not be limited to, sidewalk construction, drainage improvements, road or street intersection improvements, roadway stripping or reflectorization for improved night visibility, or signage projects.

Total funding allocated toward this priority will be subordinated to maintenance projects and can be broken down or budgeted for each heading or subcategory mentioned above. Projects can be requested by or through governmental agencies (State, County, or municipal), school or public educational entities, business groups or agencies, citizen groups or other interested parties, but under any condition must still have perpetual public maintenance agreements as a recognized part of the request.

Each request will be individually scrutinized by CTC members and will be considered on its individual merits, *not* ranked on a basis such as largest daily traffic counts, population, etc. These project requests may compete against each other, but will be considered and evaluated separately on individual merit by CTC members and budgeted accordingly.

It is the intention of the CTC that project requests within highly urbanized areas will not be classified or ranked on a standardized basis as to directly compete with project requests or needs within the smaller rural municipalities or rural areas of the County.

Priority No. 3  
Funding Reserve

*(Annual Funding Held in Reserve: 10 percent of annual fund amount)*

Funding held in this priority will be reserved for possible project cost overruns, highway bond funds, matching funds, or emergency funds during that fiscal year.

## **SECTION IV. SELECTION AND APPROVAL PROCESS OF PROJECTS**

The Charleston CTC will accept project requests on a regular basis from the SCDOT, local governments, citizens, or other groups. All requests will be routed for prioritizing to the governmental entity having jurisdiction at that location and to also identify perpetual maintenance responsibilities. Each governmental entity will have the responsibility to prioritize its list of requested projects and submit that list to the CTC for funding consideration.

The CTC will evaluate and compare each governmental entities' maintenance project requests, if any, against the recommended list generated by the Pavement Management System for supporting evidence. New construction project requests will be evaluated on an individual merit basis. Each request evaluated by the CTC must meet certain criteria, such as acceptance by a governmental agency for perpetual maintenance, the requested project is within the public domain, etc.

The CTC will discuss publicly the other intangible factors that would be subject to individual members' discretion and scrutiny.

Through this procedure the CTC will generate and fund a singular list of prioritized projects that coincides with the Transportation Plan budgetary and funding allotments as previously presented which will hopefully help meet the need of improving transportation quality in Charleston County.



## FLORENCE COUNTY TRANSPORTATION PLAN

1. OVERVIEW - The Florence County Transportation Committee (CTC) is composed of fifteen (15) members appointed by the Florence County Legislation Delegation. The members of the CTC are appointed from, and represent, all sections of the county.

It is the intention of the CTC to cooperate and work closely with the Florence County engineering administrative staff, the County Council, and City Councils to improve as many roads and other transportation facilities as possible with the funds allocated.

The CTC will also cooperate with the local Area Transportation Study Committee as it pursues its mission of prioritizing primary road needs in order to see that the primary and secondary road system of Florence County is coordinated and best serves the public.

This county-wide transportation plan, as adopted by the CTC, is submitted to the South Carolina Department of Transportation (SCDOT) for its approval in accordance with the provisions of S.C. Code {12-27-400 as passed by the 1993 General Assembly.


2. ADMINISTRATION - The Florence CTC elects and requests to receive funds from the SCDOT to administer funds that accrue to Florence County at the discretion of the CTC.

The SCDOT, through its Road, Bridges, and Engineering Departments, will provide the following services for each project:

- (A) Design engineering.
- (B) Acquisition of right-of-way.
- (C) Procurement of construction contracts.
- (D) Projects supervision.
- (E) Compliance with minority and women-owned business requirements under S.C. Code {12-27-1320.

3. PRIORITIES - The goal of the CTC will be to cooperate with the SCDOT in maintaining and resurfacing existing secondary roads in Florence County and to hard surface as many unpaved roads as practical. Consideration will be given to roads serving schools, industries and businesses, roads used for school bus routes, bridges, sidewalks, and the necessary drainage for these projects. Projects will be prioritized based upon a rating sheet prepared in cooperation with the SCDOT, Florence County Engineer's Office and after all pertinent information has been reviewed by the CTC.
  
4. PROJECTS PROGRAMMED BUT NOT LET TO CONTRACT - The CTC is in the process of reviewing all projects listed by the CTC in this category. Projects funded and approved prior to July 1, 1993, are hereby approved and should be advanced to completion as programmed. Projects funded and approved after July 1, 1993, will be considered for implementation and prioritization with all other projects by the CTC.
  
5. PRIORITIZING PROJECTS - The CTC will use information from the SCDOT, the Florence County Engineering Department, and from the municipalities concerning the condition of secondary roads and bridges within the state system. The CTC, with the Florence County Council and the Florence County Engineer, will rate and evaluate all local roads not within the state system and will solicit recommendations and input from local officials and citizens.
  
6. EQUAL CONSIDERATION - A goal of the CTC is to meet the Transportation needs of the entire county, including municipalities. Consideration will be given to the distribution of projects among the Council Districts and including the municipalities within the county. CTC will not utilize an allocation or quota system among the districts because of the necessity of considering such factors as population, traffic counts, environmental impact, right-of-way acquisition, number of households served, and similar considerations, but may use the population of districts as strictly a guide.
  
7. RESURFACE AND REPAIR - The CTC will allocate such funds as it deems appropriate on an annual basis for resurfacing, repair, and upkeep of existing secondary roads and bridges. Florence County's goal is to designate twenty percent (20%) of funds available for this purpose; however, the CTC reserves the right to select all roads and/or bridges approved.

8. REVISIONS TO PLAN - The CTC will, from time to time, review and revise the County Transportation Plan, make changes, additions, or deletions which will be forwarded to SCDOT for approval.
9. GOAL - The goal of the Florence CTC will be to provide the citizens of Florence County with the best and safest roads, bridges, and sidewalks as possible for which we are responsible.
10. In the event the Legislature elects to modify the existing law to provide for funding of "Local Paving" projects, the CTC reserves the right to allocate a portion of funds for qualifying projects. This is the program previously known as the "Rocking Program".



# PICKENS COUNTY TRANSPORTATION PLAN

## INTRODUCTION

This plan is being submitted to the S. C. Department of Highways and Public Transportation for approval as required by the amendments to S. C. Code 12-27-400 by the 1993 Appropriations Act (Section 23, Part II, Act 164 of 1993).

## PLAN DEVELOPMENT

It is the considered opinion of the Pickens County Transportation Committee that it has neither the technical expertise nor the resources necessary to develop a detailed transportation plan for the county. It is the further opinion of the committee that attempting to do so would create confusion by adding another layer of authority in an already complicated interrelated network of state, county, and municipal road systems.

## FORMULA FOR FUNDS ALLOCATION

On the basis of these opinions, it is the plan of the Pickens County Transportation Committee to utilize the technical expertise of existing road agencies and the public accountability of locally elected officials to insure that these public funds are utilized for maximum public benefit. Pursuant to these objectives the plan is to allocate the available funds from the county's "C" Fund Account in the following manner:

25% of the available funds will be used to maintain and improve state secondary roads;

Prior to the beginning of each fiscal year, the SCDOT County Maintenance Engineer will be requested to submit to the Pickens County Transportation Committee a prioritized list of projects to be funded from the "C" Fund account along with an estimated cost of each project. The Committee will then approve the projects in order of priority to the extent of funding available.

60% of the available funds will be distributed to the municipalities in Pickens County;

Prior to the beginning of each fiscal year, each municipality will be requested to submit to the Pickens County Transportation Committee a prioritized list of projects to be funded from the "C" Fund account along with an estimated cost of each project. The committee will then approve the projects in order of priority to the extent of funding available to each municipality. The funding available to each municipality will be determined by a formula using the factors of population, miles of roads, and number of

registered vehicles. Each municipality may at it's discretion elect to accumulate funds from year to year by so specifying in the annual funding request.

15% of the available funds will be placed in a discretionary fund:

The discretionary fund will be used by the Pickens County Transportation Committee to fund projects at it's discretion within the scope of it's authority not covered by any of the above funded authorities. The nature of such projects may include emergency or unforeseen requirements by the state, county, or municipal governments, special county projects, federal matching fund requirements, preliminary engineering studies, or any other project deemed appropriate by the Pickens County Transportation Committee. These funds may also be used for payment of incidental committee expenses such as travel, postage, and administration.

The Pickens County Transportation Committee reserves the right to change any of the formulas as the need to do so becomes apparent. If such action is proposed, the committee will notify each affected party and allow the parties an opportunity to appear before the committee to provide input in the decision making process. Notification of such changes shall also be made to the SCDOT.

#### AVAILABLE FUNDING

For purposes of this plan, available funding is considered to be the 2.66 cents of gasoline tax generally considered as the traditional "C" Funds money and any monies received under the 1/2 cent donor counties allocation. This plan does not provide for the distribution of any funds received under the Aid To Subdivisions Act (S.C. Code 6-27-10 et seq.).

Available funding for fiscal year 1994-95 will be the estimated funds available as described above less any previously programmed projects let to contract prior to July 1, 1994 chargeable to that year.

Available funding in all subsequent years will include all funds as described above less any charges for administration or other deductions beyond the administrative control of the Pickens County Transportation Committee.

#### PREVIOUSLY PROGRAMMED PROJECTS

It is the opinion of the committee that previously programmed projects should be continued as scheduled for the remainder of the 1993-94 fiscal year. Projects not let to contract by July 1, 1994 must be included in the requests for fiscal year 1994-95 to be considered for funding. Any funds that become available to Pickens County as a result of the cancellation of a previously programmed project shall be placed in the discretionary account and will not be considered as part of the funds available for distribution under the formula for funds allocation.

According to the amended version of SC Code 12-27-400, the York County Transportation Committee is submitting a county wide transportation plan for review and approval by the South Carolina Department of Transportation.

The York County Transportation Committee will make allocations to York County, the cities of Rock Hill and York and the towns of Clover, Fort Mill, Hickory Grove, Sharon, McConnells, and Tega Cay based on prioritization of projects according to the immediate and long term needs through a program allowing the improvement and paving of roads not currently in the state highway system. In addition, the CTC will make allocations for resurfacing projects in York County, the cities of Rock Hill and York and the towns of Clover, Fort Mill, Hickory Grove, Sharon, McConnells, and Tega Cay of roads currently within the state highway system. Furthermore, "C" Funds will be used to make improvements for emergency projects at the discretion of the CTC.


The CTC will work in conjunction with Regional Transportation Committees in the best interest of and benefit to the citizens of York County. The York County Transportation Committee will administer these projects and will request funds at a later date. We, therefore, request that all of York County's "C" Funds continue to be held and not committed to any projects unless or until notified by this committee.

According to amended Code 12-27-400, the CTC will use a procurement system which requires competitive sealed bids and public advertisement for all projects. All projects will meet specifications determined by the CTC






