The Bank of New York Mellon on Monday urged the Second Circuit to deny a payout to a group of bondholders from a \$6.3 billion Republic of Argentina trust, arguing that the claimants have no right to the funds because they haven't settled a default agreement with Argentina as it repairs its economy.

Coalition Says Public Backs More Corporate Disclosure

A coalition of the AFL-CIO and eight public interest groups, including Public Citizen and the Center for American Progress, called on the U.S. Securities and Exchange Commission Tuesday to beef up corporate reporting requirements, saying the evidence shows strong public support for more disclosures.

Enviros Urge Obama To Bar Arctic, Atlantic Drilling

Environmental groups on Tuesday pressed President Barack Obama to permanently bar new oil and gas drilling in the U.S. Arctic and Atlantic oceans, saying it's necessary in order meet the goals laid out by the global climate agreement the U.S. recently ratified.

Scientists Caution Against Trump's Plan To Duck Climate Pact

Hundreds of top scientists published an open letter on Tuesday warning against the "severe and long-lasting" ramifications that would come from the U.S. pulling out of the landmark Paris climate change agreement, as Republican presidential nominee Donald Trump has vowed to do if elected.

A new report by the Congressional Research Service warns of the "budget uncertainty" and "general management challenges" confronting the Pentagon should federal lawmakers pass a continuing resolution, suggesting a short-term move would delay important military projects from littoral combat ships to A-10 components.
