Dear Governor Haley:

Having likewise several years ago written the same proposal to John Bolton with whom I have a 45-year friendship, it is with considerable humility that I offer my congratulations Governor Haley for your UN nomination together with my earnest but modest proposal that the U.S. exert every effort to move the U.N. out of New York to the banks of the Ganges. Who better than you?

Why not? Inasmuch as the U.N. purportedly will become the disgraced Barak Obama's bully pulpit, so why not let it be in India, where 3rd world countries can try in vain to push 1st world countries around [http://en.wiki2audio.com/wiki/United_Nations_Security_Council+Consultation_room], while

surrounded by the largest English-speaking, democratic, capitalistic country in history, which, by the way, has the bomb? When 160 world leaders rendezvous amongst up-from-poverty capitalism entrepreneurship successes such as your own family, where nuclear-power India harbors historical animosity against Moslem nuclear-power Pakistan, the U.N. will linger as a debating society until the Security Council takes action.
