Dear Governor Sanford:

I am writing in response to a recent letter your office forwarded to me from Ms. Donna Rawls. Her letter was in regards to our proposed safety improvements at the subject intersection. We have reviewed her letter concerns relating to the plans to construct a roundabout at this location.

As background information, this intersection was selected for improvement through our highway safety improvement program (HSIP). The HSIP identifies locations with high crash rates and/or crash patterns throughout the state and upgrades them through infrastructure-related improvements using a rigorous four-step process:

- Step 1: Analyze Data – data provides evidence that a safety improvement is needed.
- Step 2: Identify Potential Countermeasures – select appropriate countermeasure that will improve safety.
- Step 3: Prioritize and Select Projects – due to limited resources, the South Carolina Department of Transportation (SCDOT) must prioritize projects based on cost of the project, its expected effectiveness, and expected service life.
- Step 4: Determine Effectiveness/Evaluate – project evaluations are conducted to ensure resources are used effectively.

Through the above process, it was determined that the most appropriate and cost effective countermeasure to improve safety through a reduction in crashes for the intersection of Longs Pond Road (S-204) and Nazareth Road (S-243) would be to construct a roundabout. Roundabouts have been used successfully throughout the nation and offer substantial safety advantages. They have been proven to reduce crashes by up to 87%. In addition, the geometric features of a roundabout provide a reduced speed environment, reduced fuel consumption, and improved air quality.



Please also note that our proposed design currently meets all federal and state highway design standards and guidelines. Additionally, we also considered many other factors in our design including traffic data (i.e. design vehicle and future traffic volumes) and environmental impacts (i.e. property needed and hydraulic/drainage requirements). Both of these factors have impacts on the appropriate size of the roundabout in addition to the design and location of the ditches and embankments.

In conclusion, SCDOT's Traffic Engineering staff believes that a roundabout is the most appropriate design for this location to not only improve safety but to also ensure traffic moves smoothly, efficiently and effectively. I trust you will find this information helpful and that it addresses Ms. Rawls' concerns regarding the design of this project.

Controversy continues at Port of Houston Authority

The Texas Senate late Tuesday ordered a "sunset" review of operations and policies at the Port of Houston Authority following allegations of conflicts of interest with at least one port subcontractor, according to local news sources.

A probe of the port is already under way at the Harris County District Attorney's office. The local investigation was requested by Port Authority Chairman James Edmonds and Chief Executive Alec Dreyer.

Questions have been raised about Edmonds' now-ended private contract with AECOM, an international, publicly traded design, engineering, project management and construction firm that does business with the port. Edmonds said last week that his contract with AECOM, which reported revenues of \$7.3 billion for its most recent fiscal year, ended last March.

Other issues include allegations of misuse of port assets for private functions by Dreyer and the port's ongoing contractual relationship with former spokeswoman Argentina James.

The Texas Sunset Advisory Commission reviews the performance of state agencies and, occasionally, local entities such as the port that receive state money, and can make recommendations including continuation or abolishment of a state agency, local news sources said.

What we learn about this family -- a lot -- comes mainly from thoughts and supplications conveyed in voice-overs, and revelatory moments of sweet pleasure, hovering menace (how did any of us survive the daily dangers of childhood?), repressed anger, explosive rage and, through it all, bewilderment and grief provoked by a sudden tragedy. Much of the film bespeaks the adult Jack's struggle to understand his mortal journey. What happened to the innocence of childhood? How did his beloved mother endure the pain that came to define her life? Before and after everything else, who was the father he loved deeply and hated implacably? (In an admirably minimalist way, [Brad] Pitt gives equal weight to the father's tyranny and thwarted dreams.)

Jack is not the only questioner. [Director] Malick uses his film to ask the sort of existential questions that he has posed in such earlier works as "Days of Heaven" and "The Thin Red Line": Why does misfortune befall good people? How can faith be sustained in the face of tragedy that is, by nature, incomprehensible? What of God? Where do we belong in the

raging indifference of the cosmos? To set the larger context -- larger being a colossal understatement -- the film gives us a long sequence the likes of which hasn't been since Stanley Kubrick's

"2001: A Space Odyssey" (with special effects by Douglas Trumbull, the same wizard who conjured up Mr. Kubrick's marvels). Successive segments look back to life's beginnings -- this tree has really deep roots -- and out to the rings of Saturn, the moons of Jupiter and the infinitude that surrounds us, paying special attention to violent creation and violent destruction.

"The Tree of Life" finds its own way, taking nourishment from the grandeur and more than surviving the grandiosity. Daring in concept, occasionally daffy in execution and ultimately unforgettable, Malick's film offers a heartfelt answer to the question of where we humans belong -- with each other, on this planet, bound by love.

Mr. Verrecchia,

I am a Certified Fraud Examiner and Certified Internal Auditor taking taxation and accounting courses at the College of Charleston, and recently bought a new Toshiba laptop computer.

The Toshiba replaces my MacBook that I had "registered" with your Public Safety office. This involved, of course, a trip to your office to provide your office with the serial number, my contact information, WRITING my name on the MacBook, on the bottom with invisible ink, and on the top with an "electronic engraver," and pasting on a (paper) CofC sticker.

I just placed a \$30.95 order with stoptheft for one of their patented metallic "security plates" that one pastes, permanently, to the top of the laptop clearly showing and warning potential thieves that my laptop is registered with stoptheft, making it an unattractive "resale item."

In my career, I have had two laptops stolen that I never recovered; most go to pawn shops.

Before placing the order, I called stoptheft's 800 number and was pleased to receive a call back within ten minutes.

Every now and then someone builds a better mousetrap, and this is one.

The stoptheft website has a video of someone literally ruining a computer trying to remove the stoptheft "security plate."

I believe this is something that CofC students should know about, and understand from Mr. Belfiore that volume discounts are available for colleges (such as the University of Toronto, see http://www.stoptheft.com/site/pdf/news/news_5.pdf).

When I receive this "security plate" in the mail, I'll make an appointment to show it to you and discuss this subject further.

George has said that he'll make use of internal auditors already on the staff of governmental entities over which he has authority, namely the Governor's cabinet agencies.

Sen. Sheheen's bill, S. 258 (found at http://www.scstatehouse.gov/cgi-bin/web_bh33.exe), which covers many more state entities, is supported by both the Governor and George.

S. 258 has taken two turns in the road to legislation: first, it continues as a stand-alone bill; second, it was added to the "Department of Administration" bill that is much more discussed in the news media.

My attitude is that I'll take it any way I can get it.

The legislature adjourns in less than a month and I'm not following these bills closely. If they don't get passed this session, they'll be reintroduced next session.

I've told George that the best examples of well-run Internal Audit Departments are at the SPA and MUSC, and I've already provided him information about MUSC's "hot line" that costs MUSC some \$5,000 annually.

When it's all over and the IG's office has truly broad powers, I believe they will get themselves a cracker-jack 24-7-365 live-human-being operator to get tips at any time.

The Louisiana IG office tells me they get a flood of tips on Fridays because, she figures, "people want to get bad thoughts off of their chest before the weekend."

I've had The IIA mail George literature and have encouraged him to join and attend the Palmetto Chapter's meetings.

Why don't you send George some information about SIAA? I've told him about it but don't have their membership list.

Because you need to know...

Whether you're a first-year or a seasoned student, we thought you ought to remind you about important C of C community standards. These standards involve our academic integrity policy and drug policy and the sanctions adopted because of increased student concern. While these standards are addressed during every orientation and the complete Honor System is fully outlined in the Student Handbook, the information below provides a condensed version highlighting certain sanctions.

Policy: Any student found responsible for an act of academic dishonesty (cheating, plagiarism, lying) will be assigned a XF:

* The grade of XF means failure due to academic dishonesty.

* The XF remains on the student's official transcript for a minimum of 2 years. After 2 years, the student can petition the Honor Board for removal of the X. The F will remain.

Policy: Any student found responsible for violating standards concerning only marijuana use/possession - one ounce or less - on or off campus, will be:

- * Required to pay a fee;
- * Required to undergo periodic alcohol/drug screens at their own expense;
- * Required to participate in counseling; and
- * Placed on deferred suspension - meaning that the suspension from enrollment and housing is held in abeyance as long as all screens for illegal substances are negative and all other stipulations are met.



Robin,

I have received a copy of a letter from Mr. St. Onge to Senator Fair dated April 18, 2011. The letter was faxed to me as a result of my request to his office since I was not copied on the letter.

Mr. St. Onge's letter dated April 18, 2011

In Mr. St. Onge' letter, he suggested that it would be inappropriate for me to participate in your review that he has requested. He did not provide a scope of the review with his letter nor is it clear how he defines "participate". If he had contacted me, I would have discussed with him our strongly-held belief that we are obligated to provide you any information we consider useful for your review. Also, this transmittal and the information that we will attach appears to conform to past correspondence between us. In addition to this transmittal, I respectfully request a meeting with you to discuss our thoughts and why the City of North Augusta and Riverside Partners should be paid \$486,296 by SCDOT without any further delay. I trust that since this transmittal copies Mr. St. Onge and others who would appear to be interested in your review, the transmittal will be viewed as us presenting the best available documents for your review in a transparent manner.

Issue

The issue is why SCDOT has not paid North Augusta and Riverside Partners \$486,296 as per the funding agreement (attached) between SCDOT, the City of North Augusta and Riverside Partners dated November 20, 2008. In a nutshell, SCDOT obligated itself to repay the under-run for the costs of the North Augusta interchange project in accord with the aforementioned funding agreement. The discussion of the under-run amount has been narrowed to two key issues. Those issues are:

1. Our under-run determination of \$486,296 is the only under-run determination presented by either SCDOT or us that is calibrated to the funding agreement. In this regard, we had initially presented an under-run determination of \$202,994.30. However, presentations by SCDOT

personnel caused us to realize that the determination was not as accurate as is \$486,296.

2. At this point, the factual issue regarding the under-run determination of \$486,296 is whether the funding agreement provides a basis for SCDOT to be reimbursed more than \$2,381,559 from the \$2,867,855 of funds in the funding agreement. We requested on January 26th of this year that the Chief Counsel at SCDOT designate the portion of the funding agreement that sustains a reimbursement to SCDOT in excess of \$2,381,559. To date, Chief Counsel cannot provide any such designation. As such, SCDOT cannot provide any factual basis not to pay North Augusta and Riverside Partners \$486,296. If, during your review, you receive any documents from the Chief Counsel that are represented as presenting such documentation, please allow me to comment on the documents before you complete your review.

April 11, 2011 meeting

On April 11th, a meeting was held to discuss the Riverside Partners matter. The participants were Senator Mike Fair, Tom Bardin and Andrea Truitt of the Legislative Audit Council, Cathy Hazelwood of the State Ethics Commission, Wendy Nicholas, Angela Feaster, Linda McDonald and me. During the meeting, the SCDOT position and Riverside Partners' position were presented with a high level of respectful passion. Subsequent to the meeting, Senator Fair presented his conclusions to Mr. St. Onge in his letter dated April 14, 2011 (attached). In addition to Senator Fair's letter, there are three non-SCDOT state employees who were eyewitnesses to the presentations. I would have to believe that they are available for you to interview as part of your review for Mr. St. Onge. This information is presented to you in order that you will be aware that there other independent views so that you do not need to rely solely on comments from SCDOT or me for your review. However, I also am available for a meeting to present Riverside Partners' position to you and others concurrent with the Chief Counsel presenting the position of SCDOT.

For your convenience and review, I am attaching a copy of the funding agreement and the following documents that post-date my email to the Chief Counsel on February 14th at 5:03 pm:

1. A summary dated March 14, 2011 that we prepared for a meeting on March 15th with Senator Fair, Mr. St. Onge and me. The summary was provided to Mr. St. Onge at the meeting.
2. A copy of a letter from Mr. St. Onge to Senator Fair dated March 24, 2011.

3. A copy of my annotation of Mr. St. Onge' March 24th letter and the staff's position that was attached to the letter.
4. A copy of a letter from the State Ethics Commission dated April 1, 2011 reaffirming its opinion dated December 21, 2011 that the members of the Standing DRB would be required to recuse themselves if placed in a position as described in the letter. Since the scenario described in the letter would be based on a decision by me, I can assure you that the scenario described in the letter would occur. We agreed to use an Ad Hoc DRB. However, SCDOT would not cooperate.
5. A copy of an emailed version of a letter from Senator Fair to Mr. St. Onge dated April 5, 2011.
6. A copy of an emailed version of Senator Fair' letter to Mr. St. Onge dated April 14, 2011.
7. A copy of an emailed version of Senator Fair' letter to Mr. St. Onge dated April 26, 2011.

Accounting Issue

I believe that we have made it very clear to SCDOT since last summer and in the April 11th meeting that we will not concur with its accounting for the North Augusta interchange project costs in excess of \$2,381,559. The reason we will not do so is because we know that it is not a proper accounting of those project costs. Since the issue of an improper accounting of the costs in excess of \$2,381,559 is a matter that we trust will be of interest to the Commission and to the Legislature, I am available to discuss our thoughts on the matter at your request.

Request

Please allow us to comment on the final draft of your review since I understand SCDOT will be accorded the same courtesy. Our request is intended to eliminate the possibility that there may be facts for which we are the authority that are inadvertently presented in your review in error.

Summary prepared for a meeting on March 15, 2011 between Senator Mike Fair, Secretary St. Onge and Martin Becker representing Riverside Partners, LP.

The purpose of the meeting is to brief Secretary St. Onge on \$486,297.77 owed to the City of North Augusta and Riverside Partners by SCDOT and potential accounting problems at SCDOT. Statements in the summary are supported by documents provided to us and/or held by SCDOT.

"PROJECT": US 1 and US 1 Connector (5th Street) Interchange at the Savannah River in North Augusta, South Carolina (State File Number 2.181B).

FUNDING: \$2,867,855 – SCDOT with funding from a Congressional Earmark (\$1,967,855), the City of North Augusta (\$800,000) and Riverside Partners, LP (\$100,000). As a result of the funding from the City of North Augusta and Riverside Partners, SCDOT was able to construct the entire "PROJECT". If the \$900,000 had not been provided, SCDOT had planned to construct an addition to a bridge on US 1 that would not be accessible by vehicle. A funding agreement for the "PROJECT" was prepared by SCDOT and is dated November 20, 2008. It documents the terms and agreements between SCDOT, CNA and RP. The funding by the City of North Augusta (CNA) and Riverside Partners (RP) was provided as a result of the funding agreement containing two specific provisions. They were: (1) any under-run would be returned to CNA and RP on a basis pro-rata to their contributions and (2) if a disagreement occurred, any of the three parties could request the assistance of the Standing Dispute Review Board (DRB) at SCDOT.

PAYMENT DUE to CNA and RP: Since September 2009, SCDOT has attempted to force RP to agree to an under-run amount that SCDOT could not support with the existing funding agreement. SCDOT's tactics appear to have become progressively more punitive towards RP when it resisted the efforts of SCDOT. On the basis of the funding agreement, only \$2,381,559.23 (rather than \$2.9 million plus as charged by SCDOT to the "PROJECT") was allowed to be charged to the available funding of \$2,867,855 for the "PROJECT". The \$2,381,559.23 amount includes only the Design-Build contract (\$2,285,000) and right-of-way costs expended by SCDOT prior to the initiation of "PROJECT" (\$96,559.23). Therefore, the under-run was determined to be \$486,295.77. This determination has been validated by correspondence to RP from the General Counsel for SCDOT. However, SCDOT will not pay nor discuss the payment of \$486,295.77 unless RP files a complaint with the Dispute Review Board even though RP agrees with the under-run determination of \$486,295.77.

In spite of the correspondence from the General Counsel validating \$486,295.77, SCDOT states that it disagrees with the under-run determination. If SCDOT actually disagrees with the determination, it is SCDOT that should file with the DRB since it is the disagreeing party. Again, RP agrees and accepts the under-run determination of \$486,295.77. However, SCDOT has advised RP that it will not file a claim with the DRB for its "disagreement" to \$486,295.77 (nor pay it to CNA and RP). It should also be noted that the members of the DRB are conflicted out of hearing a filing regarding the "PROJECT" on the basis of an Informal Advisory Opinion from the South Carolina Ethics Commission. The opinion was requested as a result of ex parte communication by SCDOT with the DRB although "any" ex parte communication is prohibited by the guidelines for the DRB that were promulgated by SCDOT. The members of the DRB could be subject to a \$2,000 a person fine and a public reprimand by the SC Ethics Commission if they hear a filing in this matter. If SCDOT reconsiders and decides to file with the DRB, an Ad Hoc DRB which is also used by SCDOT will be required. RP will agree to use an Ad Hoc DRB.

ACCOUNTING ISSUE: The Deputy Secretary for Finance and Administration at SCDOT will not certify that the recorded cost for the "PROJECT" are calibrated to the funding agreement, and has reportedly withdrawn from the "PROJECT". Also, SCDOT will not certify that the costs it charged to the "PROJECT" are legal. The request for this certification has been outstanding since July 12, 2010. These apparent irregularities in the "PROJECT" accounting are of concern to RP.

REQUEST: Please provide a check to the City of North Augusta for \$432,262.91 and to Riverside Partners, LP for \$54,032.86 since SCDOT is not filing a disagreement with the DRB to the under-run determination of \$486,295.77. Also, we request that SCDOT indemnify us from any adverse consequences due to accounting irregularities by SCDOT for this "PROJECT".


Dear Mr. Becker:

Enclosed is a response by SCDOT staff to your summary. I see no reason why this matter could not be referred to the Standing Dispute Review Board ("SDRB") in accordance with the Funding Agreement. I find no merit to the argument that SCDOT ex parte communications with the SDRB have tainted the ability of the SDRB to hear this case. In addition, as long as SCDOT assigns the case to the SDRB, rather than allowing the SDRB members to decide themselves whether to hear the case, there should be no violation of the State Ethics Commission General Counsel's opinion.

Senator Fair has made a suggestion that I hear the case to save the State the cost of a dispute review board. I am willing to do that provided we limit the hearing to two hours and the parties will agree to be bound by my decision. If you are willing to resolve this dispute in this manner, please so indicate at the foot of this letter and return a copy to me with the times you would be available in the next two months for a hearing in Columbia. I will coordinate your available dates with my staff's schedule and my own and let you know of a mutually convenient time for the hearing.

PROJECT COSTS - SCDOT disagrees, as Mr. Becker asserts, that the allowable project costs were limited to the cost of the design build contract with Mabus (\$2,285,000) and the right of way costs (\$96,559), for a total project costs of \$2,381,559. Mr. Becker has not included internal SCDOT costs of \$544,579 for preconstruction work, monitoring and inspection of construction, and testing of materials. These costs are required for projects built to federal and state standards and are typical charges to federal projects. Adding the SCDOT internal costs, the total cost of the project was \$2,925,075. SCDOT's Deputy Secretary of Finance and Administration has not, as Mr. Becker asserts, "withdrawn from the project."

UNDER-RUN - The Funding Agreement provides that "(u)nder-runs, if determined at Project completion, would be refunded to City and Riverside in accordance with percentage of Project funding participation." Based on the total project costs of \$2,925,075, there was no "under-run." In fact, the Project over-ran by approximately \$57,000. Therefore, neither Riverside Partners, nor the City of N. Augusta, is entitled to a refund. Contrary to Mr. Becker's assertion, SCDOT General Counsel has not agreed with Mr. Becker's calculation that there was an under-run of \$486,296.

EX-PARTE COMMUNICATIONS - The only communications made with the Standing Dispute Review Board (SDRB) was when SCDOT's Director of Construction's assistant, Mary Stepro, called the SDRB chairman to see if his schedule would be clear for a hearing. See attached copies of Affidavits of Mary Stepro and Danny Shealy. These are not substantive ex parte communications.

STATE ETHICS COMMISSION OPINION - State Ethics Commission's Counsel's Cathy Hazelwood stated that in her opinion the dispute review board members would have to recuse themselves from making a determination of whether to hear the dispute since they would have an economic interest in hearing the matter. (The Board members are paid for their services.) In this case, the dispute review board would not make the determination of whether or not to hear the case. They would simply be assigned the case to hear in accordance with the Funding Agreement and SCDOT's Claims Procedures.



Re: Request for Informal Opinion

Dear Mr. Becker:

Thank you for your recent request for an informal opinion. An informal opinion is the opinion of the Commission staff based on the State Ethics Commission's prior published opinions; however, an informal opinion is not binding on the Commission. S.C. Code Ann. §8-13-320 (Supp. 1997). The Commission's jurisdiction is limited to the applicability of the Ethics, Government Accountability, and Campaign Reform Act of 1991. This opinion is based on the facts as you submitted. Any material deviation from the submitted facts or failure to disclose relevant information will void this opinion. An opinion does not supersede any other statutory or regulatory restrictions which may apply to this situation.

Issue

In your letter you state the following:

I have received additional information since the Informal Advisory Opinion from your office dated December 21, 2010. As such, I would appreciate an update of your office's opinion after your review of the attached letter from General St. Onge to me dated March 24, 2011. In short, is there anything in the General's letter and/or the attachments that would cause your Office to modify its Conclusion if the Issue section in

your letter remains the same including: that one of the parties before the dispute review board will not agree for SCDOT to assign the case to the board without the board members being requested to decide themselves whether to hear the case? Also, what is the potential penalty for dispute review board members for a violation of the State Ethics Act?

Law

Section 8-13-700(B) states in part:

No public official, public member, or public employee may make, participate in making, or in any way attempt to use his office, membership, or employment to influence a governmental decision in which he, a member of his immediate family, an individual with whom he is associated, or a business with which he is associated has an economic interest. A public official, public member, or public employee who, in the discharge of his official responsibilities, is required to take an action or make a decision which affects an economic interest of himself, a member of his immediate family, an individual with whom he is associated, or a business with which he is associated shall:

(1) prepare a written statement describing the matter requiring action or decisions and the nature of his potential conflict of interest with respect to the action or decision;

* * *

(5) if he is a public member, he shall furnish a copy to the presiding officer of any agency, commission, board, or of any county, municipality, or a political subdivision thereof, on which he serves, who shall cause the statement to be printed in the minutes and shall require that the member be excused from any votes, deliberations, and other actions on the matter on which the potential conflict of interest exists and shall cause such disqualification and the reasons for it to be noted in the minutes.

Discussion

As previously noted Section 8-13-700(B) requires that, in the event of a conflict of interest, a public member must recuse himself from participating in certain governmental actions or decisions, which could affect the public member's economic


interest. Economic interest requires an interest of \$50 or more. My December 21, 2010 informal opinion provided that the Act required the dispute review board members to recuse from making a determination of whether to hear a dispute after an objection if their economic interest in hearing the case was \$50 or more.

The proposed change in the hearing procedure is that the board members will not be asked to make a determination on a party's objection, but they will be assigned the matter without making a finding on the objection. If the objection is made before the dispute review board members, assigned or otherwise, the members are again placed in the position of making a decision that may affect their economic interest.

Penalties for a violation of the Ethics Reform Act include a public reprimand up to a \$2000.00 administrative fine.

Dear Mr. St. Onge:

I have reviewed your letter to Mr. Martin Becker dated March 25, 2011. There appears to be a misunderstanding on your part regarding the request in my March 24th letter to you. When I requested that you have the matter "argued" before you, my request was not intended to preclude a DRB process but rather for you to maybe save the need (and cost) for a DRB process. I hope you will revise your offer to Mr. Becker for a two hour session without prohibiting their right to a DRB process. I would be delighted to host that discussion in my office.

The issue that Mr. Becker has presented is interesting since it has allowed us to look inside the operations of construction at SCDOT in a way that has not been available to us in the past. The sunshine from this exercise creates a concern that local governments across the State are being subjected to an accounting of project costs that cannot be verified by SCDOT with legitimate accounting and without the use of a DRB process to appeal the decisions by SCDOT. To the extent that our concerns are correct, the reported costs for construction by SCDOT are being presented to the Legislature in a flawed manner.

It is not clear from your letter why it focuses on the DRB and a hearing. The reason is that the staff position you attached does not provide any specific language in this funding agreement between SCDOT, the City of North Augusta, and Riverside Partners that allows SCDOT to be reimbursed for costs in excess of \$2,381,559 from the \$2,867,855 of available funds cited in the funding agreement. Further, we are advised that although it was requested on January 26th of this year, the Chief Counsel at SCDOT cannot provide any language in the funding agreement to justify reimbursements to SCDOT above \$2,381,559. Therefore, your staff has not presented any factual reason not to pay North Augusta and Riverside Properties \$486,296.

If your staff continues to insist on a DRB, it should note in the letter dated April 1, 2011 from the State Ethics Commission that its efforts to circumvent the State's Ethic Act did not work. I have attached the letter from the State Ethics Commission along with Mr. Becker's request of March 30th. Clearly, the
