The only person close is a Margert (not Margaret) who is just a year different in age but in Marion county (I am not confident it is the same person). This particular Marion client received 2 units of service once in 2004.

There are two people with the same name and age within a year, but one is in Sumter and the other in Spartanburg.
The Sumter person was last assessed in 1996, never received any services in AIM and the last status update is 2005.
The Spartanburg person was just assessed two weeks ago and therefore is not likely to have suddenly moved to Marion and seems to have a support network.

There are a few Maggies near the right age, but they are not in the region and their last update is 2007 and 2006.

The obituary doesn't seem to have hit the net yet, so I have no other information other than name and county.
