Governor Nikki Haley News:

Associated Press: Haley seeks storm disaster declaration for SC

Gov. Nikki Haley has asked President Barack Obama to declare almost half of South Carolina a federal disaster after last month's winter storm that caused at least \$430 million in damage and left hundreds of thousands in the dark.

Note: "Insurance coverage for the damages to electrical infrastructure is insignificant in relation to the extraordinary losses sustained by municipal utilities and electrical cooperatives," the governor wrote.

The State: SC State, \$13.6 million behind on bills, needs cash infusion by April

S.C. State University, suffering a \$13.6 million cash shortfall, has unpaid bills dating back to October and has been put on notice by vendors who provide food to students, washing machine maintenance in dorms and the school bookstore, college president Thomas Elzey said Wednesday.

Note: The board, led by Gov. Nikki Haley, did not offer a loan and suggested Elzey try to get the money from state lawmakers.

Legislation has been introduced by state Rep. Shannon Erickson, R-Beaufort, that would instruct the S.C. State Ports Authority to sell the Port of Port Royal by June 30, 2015, or see it sold at auction. If a sale is pending on the 317-acre property — 52 acres of which are buildable — the Ports Authority would have an additional 90 days to finalize it, according to the legislation, which was introduced Tuesday.

A House panel approved a bill that would lift the ban on liquor sales on Election Day and end the governor's ability to close stores on holidays. South Carolina is the last state in the country that bans liquor sales on Election Day. The Election Day ban costs S.C. merchants an estimated \$1.1 million in sales and the state about \$105,000 in taxes.

Note: Gov. Nikki Haley has not issued an executive order to close liquor stores since starting her term in 2011.

William Kyle Carpenter, a Marine Corps veteran from Gilbert who was severely wounded in 2010 while fighting in Afghanistan, will receive the Medal of Honor, the nation's top award for valor, according to a report in Marine Corps Times. He would be the third Marine to receive the Medal of Honor from the wars in Iraq and Afghanistan and the first South Carolinian to receive the decoration since the Vietnam War.

President Barack Obama's proposed budget for 2015 includes funding for federal studies related to the proposed deepening of Charleston Harbor for larger ships, officials said. South Carolina officials want to deepen the state's main shipping channel to at least 50 feet from 45 by the end of the decade. A feasibility study is currently underway by the U.S. Army Corps of Engineers and expected to be finished by fall 2015.
