MINUTES OF BUDGET AND CONTROL BOARD MEETING

MARCH 7, 1978

On March 7, 1978, W. T. Putnam polled all Budget and Control Board members pertaining to the two matters which are set forth below:

(1) At a previous meeting, the Budget and Control Board had received a request from Dr. James Holderman, President of the University of South Carolina for salary adjustments for numerous positions at his institution. At that time the Board had agreed to appoint a subcommittee composed of Mr. Grady Patterson and Mr. Earle Morris to consider these requests.

On March 2, 1978, Messrs. Patterson and Morris met with staff members, reviewed the request of Dr. Holderman and came to certain conclusions. At the request of the subcommittee these findings were conveyed to Dr. Holderman by Jack Mullins and W. T. Putnam on March 8, 1978 at which time Dr. Holderman furnished additional information and requested further consideration of three positions.

After the subcommittee had given further consideration to the request of the University of South Carolina, the following recommendations were made to the Budget and Control Board through a telephone poll:
