SECTION 1: On motion of Commissioner Harrell, seconded by Commissioner Hardee, the Commission unanimously passed a motion approving the January 22, 2004 Commission Minutes; copies of which had been previously mailed to each member of the Commission.

SECTION 2: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion approving the request of the Charleston County Transportation Committee to revise their transportation plan, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the request of the Department to advertise, negotiate and select a consulting firm experienced in all phases of underwater bridge inspection, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the request of the Department to select a Historically Black College and University (HBCU) to administer the Highway Transportation Careers Training Program, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in removing roads from the State Highway System, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in correcting the descriptions of sections of highways previously added the State Highway System, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the action of the Department in adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway letting of January 13, 2004, as shown in detail in the Appendix.

SECTION 10: Commissioner Stoddard reported for the Invitations and Resolutions Committee and made a motion that the Commission adopt a Concurrent Resolution from the General Assembly naming the intersection of SC 176 and West Main Street in the Town of Pacolet the "Voight Milton Epting Intersection". Commissioner Hardee seconded the motion and the Commission unanimously approved.

Be it hereby resolved that the Commission has reviewed the provisions of Senate Bill S-841 relating to the powers of the chief information officer and the Commission does not support the transfer of information technology resources from the SCDOT to the Office of Chief Information Officer and;

The Commission hereby requests that the South Carolina Department of Transportation be excluded from any provisions of the bill that would allow for the transfer of information technology resources.

SECTION 13: On motion of Commissioner Truluck, seconded by Commissioner Mack, the Commission unanimously passed a motion to tentatively approve the FY 04 SCDOT Transportation Enhancement Funding, as shown in detail in the Appendix.

SECTION 14: Chairman stated that the next order of business was the election of a vice chairman of the Commission. Commissioner Mack nominated Commissioner Harrell. Commissioner Truluck seconded the nomination. Commissioner Stoddard the made a motion to close the nominations and elect Commissioner Harrell by acclamation. Commissioner Turner seconded this motion and Commissioner Harrell was elected vice chairman by acclamation.

1. File 42.233A / US Route 221 / Spartanburg County

During construction of improvements on Road S-86, under File 42.297 in Spartanburg County, near the Town of Roebuck, the Department acquired right of way for Road S-86, by Deed to Right of Way from Paul V. Moore dated July 26, 1948 and from H. G. Grim by Deed to Right of Way dated September 2, 1948.

A request was received from the adjacent property owner asking the Department to sell a small piece of abandoned right of way of Road S-86 that was made surplus after the relocation of Road S-86. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.86 of an acre of land to First Piedmont Service Corporation was executed on October 29, 2003 in consideration of \$10,104.00.

2. File 810.493.3 / Route I-526 / Berkeley / Charleston County

During construction of improvements on Interstate I-526, it became necessary to acquire right of way for an access road, under File 810.439.3 in Berkeley County, near the City of North Charleston at Daniel Island. The Department acquired fee simple title for the access road, by Condemnation from Rebecca Gibbs, dated January 27, 1987, from the Estate of Cupid Polite dated January 27, 1987, from Jimmie & Rena Green dated January 27, 1987 and by Title to Real Estate from Jessie Green dated January 16, 1987.

This office was contacted by the Grantee's attorney asking the Department to change the description of the deed. The request was reviewed and the change was made. Therefore, this corrective quitclaim deed for approximately 1.2 acres of land to South Carolina Electric & Gas Company was executed on December 18, 2003.

3. File 22.571 / US Route 521 / Georgetown County

The Department acquired Road S-22, located in Georgetown County, near the Town of Sampit, under the Construction Act on April 16, 1953.

A request was received from an adjacent property owner asking the Department to convey a small parcel of the abandoned roadbed. The request was circulated to the Engineering sections to determine if the subject parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.24 of an acre of land to Six-Mile Crossing Church was executed on December 18, 2003 for \$1,000.00.

4. File 23.327 / Route I-385 & Road S-453 / Greenville County

During construction of improvements on Road S-453 (Harrison Bridge Road), under File 23.237A in Greenville County, near the City of Simpsonville, the Department acquired right of way for Road S-453 (Harrison Bridge Road), by Title to Real Estate from Bethlehem Baptist Church dated August 9, 2002.

A request was received from the right of way agent in the field indicating that due to plan revisions, right of way previously acquired from the Grantee was no longer needed. Subsequently, additional right of way was needed to be acquired from the Grantee for the Frontage Road. The agent has asked that the Department exchange the surplus right of way for new right of way needed for the project. Therefore, a Gratis Quitclaim Deed for approximately 0.109 of an acre of land to Bethlehem Baptist Church was executed on December 18, 2003.

5. File 32.615 / SC Route 35 (12<sup>th</sup> St Extension) / Lexington County

During the construction of improvements to Road S-371, the South Carolina Department of Transportation acquired small sections of the road from the Town of Cayce by letter dated June 26, 1953, under File 32.350; during the construction of improvements on Road S-699 the Department acquired small sections of the road from the City of Cayce by letter dated May 4, 1966, under File 32.500; and during construction of improvements on S.C. Route 35 (12<sup>th</sup> Street Extension) under File 32.615 in Lexington County, in the City of Cayce, the Department acquired right of way for U.S. Route 35 (12<sup>th</sup> Street Extension) from the Cayce Masonic Lodge No. 384, A.F.M., a South Carolina Corporation, by Title to Real Estate, dated October 18, 1994.

A request was received from the adjacent property owner asking the Department to convey a small section of abandoned roadbed and an uneconomic remainder parcel. The request was circulated to the Engineering sections to determine if the small section of abandoned roadbed and the remainder parcel could be declared surplus. After review, it was determined that the abandoned roadbed and the remainder parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.48 of an acre of land to Lewis M. Priester with a consideration of \$8,500.00 was executed on December 18, 2003.

6. File 23.227/ Route I-385 / Greenville County

During construction of improvements on Fairview Road, under File 23.395 in Greenville County, near the City of Greenville, the Department acquired right of way for Fairview Road, by Condemnation from A.G. Huff dated August 7, 1956, by Right of Way Easement from T. Walter Brashier dated February 15, 1986 (File 23.104A), by Condemnation from Hargrove Bowles, III dated August 23, 1999, by Title to Real Estate from KFC National Management Co. Dated July 7, 1999, and by Title to Real Estate from Spinx Investments Inc. dated September 14, 1999 (File 23.277A).

A request was received from an adjacent property owner who has asked that the Department sell any available surplus right of way produced by the relocation of Fairview and Grandview roads on the above project. The request was circulated to the Engineering sections to determine if the said parcel could be declared surplus. After review it was determined that the said parcel could be declared surplus. Therefore, a

Quitclaim Deed for approximately 0.742 of an acre of land to Lenoir DT Investors, LLC, A North Carolina Limited Liability Company in consideration of \$193,929.00 was executed on December 18, 2003

7. Road S-75 (East McBee Avenue) / Greenville County

During construction of improvements on Road S-75, in Greenville County, near the City of Greenville, the Department acquired right of way through The Beltline Act.

A request was received from the City of Greenville asking the Department to abandon a small portion of East McBee Avenue to the city. The city agreed to take over the maintenance responsibility and the commission approved the abandonment of the subject parcel in June of this year. Therefore, a Gratis Quitclaim Deed for approximately 0.856 of an acre of land to The City of Greenville was executed on December 9, 2003.

8. File 39.579 / SC Route 93 / Pickens County

During construction of improvements on SC Route 93, under File 39.579 in Pickens County, near the Town of Central, the Department acquired right of way for SC Route 93 by Title to Real Estate from James Samuel Cox dated February 14, 1990, by Title to Real Estate from the Jamie Reese Estate on November 9, 1987, by Title to Real Estate from Earnest Reese on November 19, 1987 and by Title to Real Estate from Maggie Burress on March 14, 1988.

A request was received from an adjacent property owner asking the Department to sell a small piece of surplus property. The request was circulated to the Engineering sections and after review it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.32 acre of land to James Samuel Cox was executed in consideration of \$7,550.00.

9. File 23.234 / US Route 29 (Wade Hampton Boulevard) / Greenville County

During construction of improvements on US Route 29, under File 23.234 in Greenville County, near the City of Greer, the Department acquired right of way for US Route 29, by Deed To Right of Way from Ella P. Groce dated December 4, 1940.

A request was received from the adjacent property owner asking the Department to reduce the present 100'x 100' triangle to a 65'x 60 triangle. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.11 of an acre of land to A&C Development, LLC in consideration of \$13,600.00 was executed on January 14, 2004.

10. File 32.691 / SC Route 12 / Lexington County

During construction of improvements on SC Route 12 (Jarvis Klapman Blvd), under File 32.691 in Lexington County, near the City of Columbia, the Department acquired right of way for SC Route 12 (Jarvis Klapman Blvd), by Title to Real Estate from Jerry S. Hutto, Jr., dated October 4, 1973.

A request was received from an adjacent landowner asking the Department to sell a small uneconomic parcel of land adjacent to his property. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. The property was appraised and the requestor made an offer for the appraised value of \$14,500.00. Therefore, a Quitclaim Deed for approximately 0.24 of an acre of land to Eugene and Kaye Ford in consideration of \$14,500.00 was executed on November 20, 2003.

11. File 4.836 / SC Route 28 / Anderson County

During construction of improvements on SC Highway 28 Bypass, under File 4.836, near the City of Anderson, in Anderson County, the Department acquired right of way from Mr. Elias T. McGee by Right of Way Easement dated July 21, 1975.

A request was received from the adjacent owner asking the Department to convey a small section of the abandoned roadbed. The request was circulated to the Engineering sections to determine if the section of abandoned roadbed could be declared surplus. After review, it was determined that the abandoned roadbed was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.449 of an acre of land to Discount Bark Company, Inc. in consideration of \$8,800.00 was executed on January 28, 2004.

12. File 8.720 / US Route 17 / Berkeley County

During construction of improvements on Road S-61, under File 8.382 in Berkeley County, near the Town of Goose Creek, the Department acquired right of way for Road S-61, by Condemnation from G. Gilbert Harmon dated November 8, 1962 by Condemnation from C. M. Altman dated November 8, 1962 and by Condemnation from Lorean D. Thompson dated September 28, 1962.

A request was received from the adjacent property owner asking the Department to sell a small piece of Old Road 61 (Myers Road). The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.24 of an acre of land to Jordan Oil Co., Inc. in consideration of \$8,300.00 was executed on January 28, 2004.

13. File 26.100A / US Route 501 / Horry County

During construction of improvements on Road S-600, under File 26.314 in Horry County, near the City of Myrtle Beach, the Department acquired right of way for Road S-600, by Right of Way Easement from the City of Myrtle Beach dated November 7, 1959 and from Resort Land Development by Title to Real Estate dated September 28, 2000 under File 26.100A.

A request was received from the adjacent property owner asking the Department to sell a small portion of the abandoned Road S-600 and a small piece of surplus right of way acquired under the Grissom Parkway project. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for total of approximately 2.19 acres of land to Carolina Resort Land Development, A SC General Partnership in consideration of \$213,622.20 was executed on January 28, 2004.

The Department does not have all the resources to perform this type of work so the use of a consulting engineering firm is justified.
