We have a plant in Walterboro and last month our Managing Director had been denied entry into the US on grounds of an "invalid" visa.

With our repeated conversation with Kay Maxwell and the Congressman's office, inspite of the visa being an acceptable one, we took the best course of action and applied for a new visa as recommended by the US customs to ensure this problem does not repeat.

We filed our case and received notification of the receipt and review of the visa application from the US a week ago.
