- Notes:
- (1) H. 3066 renames LPITS as the Legislative Services Agency - this is not a new agency. The new Legislative Fiscal Office and Office of Precinct Demographics would be LSA components, and not new agencies.
 - (2) Office of Executive Policy and Programs (currently its own agency) is merged into the Department of Administration.
 - (3) Procurement Oversight Board receives Materials Management Office and State Engineer's Office. Department of Administration receives IT Procurement.
 - (4) Department of Administration receives Office of State Budget, except employees who prepare impact statements go to Legislative Services Agency (Legislative Fiscal Office).
 - (5) Executive Budget Office is a component of the Department of Administration, and not a new agency. EBO is a nullity and would be embedded within the Office of State Budget.
 - (6) Office of State Auditor is abolished, with its duties assigned to the Office of Inspector General, which was established earlier in 2012 and is not a new agency under H. 3066.
 - (7) Charleston Navy Base Museum Authority is established as a component of the Charleston Naval Complex Redevelopment Authority, and is not a new agency.
 - (8) Deferred Compensation Commission is abolished, with its duties assigned to the Public Employee Benefits Agency.
