On the study,

- We have made a few grammatical and formatting edits, but no substantive changes;
- I would especially like to know if the intro referencing you and the Gov's Office is okay;
- While we are excited about the report, I was not going to put it on our webpage until either you said okay or y'all make it public and we get asked for a copy; just let me know how y'all like to proceed.

On the monthly revenue,

- We will be sending our first briefing packet to all tomorrow.
- Overall, revenues, especially Paid with returns, came in stronger (DOR didn't get it all in in Apr). At the present time, our "surplus" has increased from the \$34 million last month to about \$70 million (or more if you take most optimistic scenario from each staff)

- I have talked to the legislative budget staffs and have given them a head's up that while we may not change the forecast, the final surplus discussed last meeting of \$34 million looks to be low at this time; I thought you might want to share this with the Gov's Office too as the budget prioritization and negotiations continue.
- Still no reason to change the FY 15 estimate – sales and withholdings continue to lag; corporate income and individual paid with returns are carrying the day and may not repeat.

Yes, Don came by on Tuesday and shared his news ... good for him but sad for us.

Also, I did a show for Carolina Business Review last week and Chris Williams said to tell you hello. I think the shows air tomorrow in Charlotte and next week in SC (our group discussed the first six months of the economy in SC and NC, though Chris did bring up some other issues on which I hoped I stayed neutral). Let me know if there is anything else ... talk to you in the morning,
