SECTION 1: The Minutes for the meeting of January 16, 1992; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving monthly reports as published by the Department of activities for the month of January, 1992.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00 during the month of January 1992, as shown in the Appendix. Commissioner Bailey abstained from voting on this action.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into a research agreement with Clemson University to conduct an HPR study entitled "A Laboratory and Field Investigation of Rubberized Asphaltic Concrete Mixtures - Pelham Road" in the amount of \$26,992.00, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 1 with B. P. Barber and Associates, for the study phase of design for wastewater treatment facilities at rest areas along I-95 in Colleton County and I-26 in Newberry County in the amount of \$57,000.00, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 1 with Stevens & Wilkinson, Inc., for I-385 rehabilitation - from south of U. S. Route 221 to east of I-26/S. C. 56 interchange - Laurens County at an estimated cost of \$1,055,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 1 with CRS Serrine, Inc., for I-385 rehabilitation - from Greenville County Line to South of S. C. Route 101 - Laurens County at an estimated cost of \$713,000.00, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 3 with Post, Buckley, Schuh, & Jernigan, Inc., for additional engineering for completion of preliminary and right of way plans for 11.36 miles of the Laurens Bypass, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to transfer \$70,000.00 from the Headquarters Building Capital Improvement budget to the Headquarters Modular Equipment budget, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion allocating \$73,618.00 for rental and upfitting, of leased office space, as shown in the Appendix.

SECTION 14: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a quitclaim deed dated January 27, 1992 conveying approximately 2,321.69 SF parcel of land in Abbeville County to C. Y. Thomason for the consideration of \$950.00, as shown in the Appendix.

SECTION 15: The Commission unanimously passed a motion accepting the sale by the Department of surplus right of way property in Greenville County located on U. S. Route 25 to Steven Boyd for the low bid of \$45,000.00, as shown in the Appendix.

SECTION 16: The Commission unanimously passed a motion accepting the sale by the Department of surplus right of way property in Greenville County located on Road 21 to Ken Rumminger for the low bid of \$2.00, as shown in the Appendix.

SECTION 17: The Commission unanimously passed a motion accepting a report by the Department of right of way payments in State Secondary "C" Construction Program for Aiken, Cherokee, Fairfield, Horry, Lexington, Pickens, and Richland Counties, as shown in the Appendix.

SECTION 18: The Commission unanimously passed a motion approving the sale of surplus used motor vehicles and equipment located at the Department's Equipment Depot, Shop Road, Columbia, South Carolina, bids for which were received on January 22, 1992, as shown in the Appendix.
